May I seek your assistance to perform a detailed mechanical inspection of the <u>7 vehicles</u> below. Those in red are deemed to be <u>urgent</u>:

a. Case IAFP-IB-20210531 - Motorcycle, FBE5320T (TP/IP/17949/2021)

On 10 April 2021 at about 8.37 p.m., an accident took place where a motorcycle rear ended a motorcar along Jurong East Central. As a result of the accident, the rider was conveyed to hospital with serious injuries. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence raised by the defendant and to rule out foul play.

b. Case IAFP-IB-20210531 - Mechanical Inspection of Motorcycle, FBP4495X (TP/IP/24079/2021)

On 16 May 2021 sometime before 3.36 p.m., the Deceased was riding his motorcycle when it suddenly wobbled and veered to the left and collided into the lamp post at the said location. As a result of the accident, the Deceased sustained multiple injuries and was conveyed by AB to the hospital. He succumbed to his injuries and was pronounced dead by Dr Andrew at 4.59pm. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence raised by the defendant and to rule out foul play.

c. Case IAFP-IB-20210531 - Mechanical Inspection of Motorcar, SJT6426S (TP/IP/25917/2021)

On 2 May 2021 at about 2.45 p.m., the driver of the said motorcar claimed that his vehicle was still in reverse mode when his vehicle surged forward to the opposite direction, mounted the road kerb and went up the slope before colliding onto the wall at the perimeter of China Embassy and rolled backwards into a small drain before coming to a halt. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence raised by the defendant and to rule out foul play.

On the 13 May 2021 at about 10.21am, the involved party was driving his motorcar along Sungei Road and came to a stop by the junction of Weld Road. Upon checking clear. The involved party proceeded to move off with intention to drive straight across the junction when he collided onto the Deceased, who was riding his Power Assisted Bicycle(PAB)along Weld Road towards the direction of Jalan Besar, from the involved party's right to left. As a result of the collision, the Deceased was flung off his PAB to the side of the road and sustained head injuries. He was conveyed to SGH in an unconscious by the ambulance and succumbed to his injuries on the same day and was pronounced dead by Dr Sherry of SGH at 6.03 p.m. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence raised by the defendant and to rule out foul play.

f. Case IAFP-IB-20210511 - Mechanical Inspection of Motorcycle, FBE9254A (TP/IP/24033/2021)

On 15 May 2021 at about 10.13 p.m., the deceased was riding along Sims Avenue East towards the direction of Bedok on lane 1 of 4-lane road. Before the signalised cross junction of Jalan Kembangan, the deceased veered to the right and collided onto the kerb before falling. was reported to be unconscious and was sent by ambulance to CGH. On 17 May 2021 at about 8.52 p.m., the deceased was pronounced dead by Dr C Thiaghu at CGH SICU Bed 6. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence raised by the defendant and to rule out foul play.

g. Case IAFP-IB-20210511 - Mechanical Inspection of Motorcycle, FBN3988H (TP/IP/25075/2021)

On 20 May 2021 sometime before 9.07 p.m., the Involved Party was riding alone on his motorcycle and was travelling straight along Kampung Bahru towards Eu Tong Sen Street, after slip road of Lower Delta Road, on lane 3 of the 3-lane road. Moments later, the Involved Party's motorcycle collided into the Deceased who was walking across the road on lane 3, directly ahead of the Involved Party. Due to the impact, the Involved Party skidded, fell off from his motorcycle and landed on the road, together with the Deceased. It was not known which direction the Deceased was travelling from or heading to. The Deceased sustained head injury and multiple fractures and was conveyed to Singapore General Hospital by an ambulance. She succumbed to her injuries and was pronounced dead on the same day at 10.14 p.m. by Dr Teo. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence raised by the defendant and to rule out foul play.
