CIRCUMSTANCES OF ACCIDENT

I WAS DRIVING MY FAMILY BACK FROM ADMIRATLY PARK BACK HOME TO BISHAN,I WAS TRYING TO FILTER LEFT FROM LANE 1 TO 2 WHEN I NOTICED THE CAR IN FRONT OF ME SUDDENLY SLOW DOWN ,THE ROAD SURFACE WAS RATHER WET AFTER HEAVY RAIN , I APPLIED BRAKES AS HARD AND JUST AS I COULD BUT I COULD NOT STOP IN TIME AND HIT THE REAR BUMPER AT THE VEHICLE SJM1830C . BOTH OUR CARS STOPPED AND TAKE PHOTOS OF THE INCIDENT . THE DRIVER AND I EXCHANGED PARTICULARS AND I TOLD HIM TO REPORT THE INCIDENT AT HIS END AND THAT THE INSURERS AT BOTH PARTIES WOULD CONTINUE TO RESOLVE THE CASE . MR NEO ADVISED ME TO CHECK ON HIS CLIENT PASSENGER WHO WAS A MIDDLE AGED LADY WITH SHOULDER LENGTH HAIR SITTING ON THE REAR LHS PASSENGER SEAT . HE OPENED THE RIGHT REAR CAR DOOR AND I APOLOGISED TO HIS PASSENGER FOR ANY INCOVENIENCED CAUSED . THE LADY PASSENGER WHO DID NOT SEEMS TO BE INJURED OR AFFECTED BY THE INCIDENT IN ANY WAY , ACKNOWLEDGED MY APOLOGY . THEREAFTER MR NEO CLOSED THE PASSENGER DOOR AND WE BOTH PARTED WAYS , I DRIVE STRAIGHT HOME AFTER THE INCIDENT .

He opened the right rear car door, and I apologized to his passenger for any inconvenience caused. The lady passenger, who did not seem to be injured or affected by the incident in any way, acknowledged my apology. Thereafter, Mr Neo closed the passenger door, and we both parted ways. I drove straight home after the incident.
