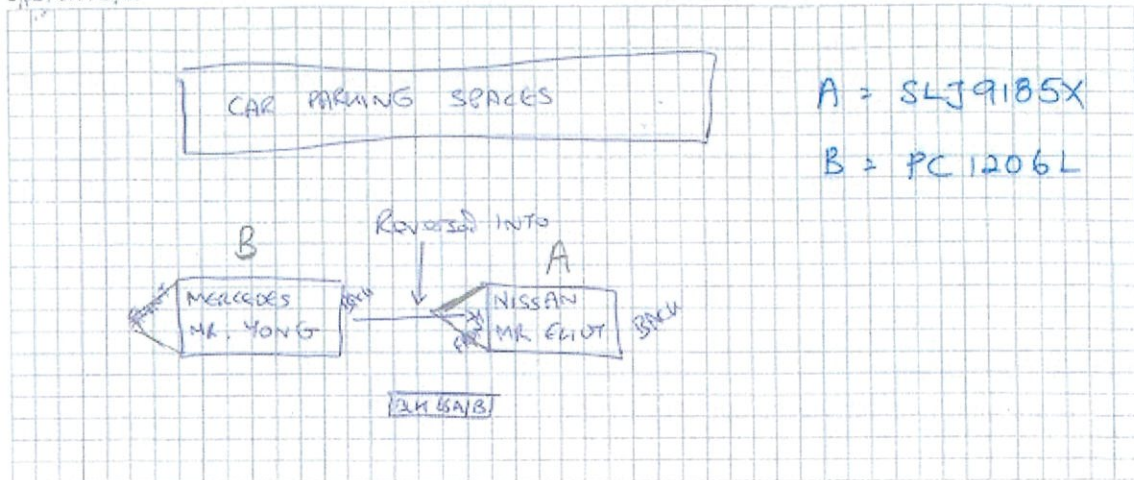

DRIVER TAN TAI YONG, ~~VEHICLE~~ MERCEDES PC1206L DROVE INTO THE CAR PARK AT WATERSCAPE AT CAVENAGH AND PULLED UP AHEAD OF THE ENTRANCE OF BLOCK 65A. I, ANDREW DAVID ELIOT, DRIVING NISSAN QASHQAI, SLJ9185X FOLLOWED AND STOPPED 1-2 METRES BEHIND THE VEHICLE OF MR. TAN TAI YONG. I WAS STATIONARY AND WAITING FOR MR. TAN TAI YONG TO MOVE FORWARD SO THAT I COULD PARK ON THE RIGHT HAND SIDE. THEN MR TAN TAI YONG REVERSED HIS MERCEDES HITTING THE FRONT OF THE NISSAN QASHQAI I WAS STATIONARY IN.
