SKETCH PLAN



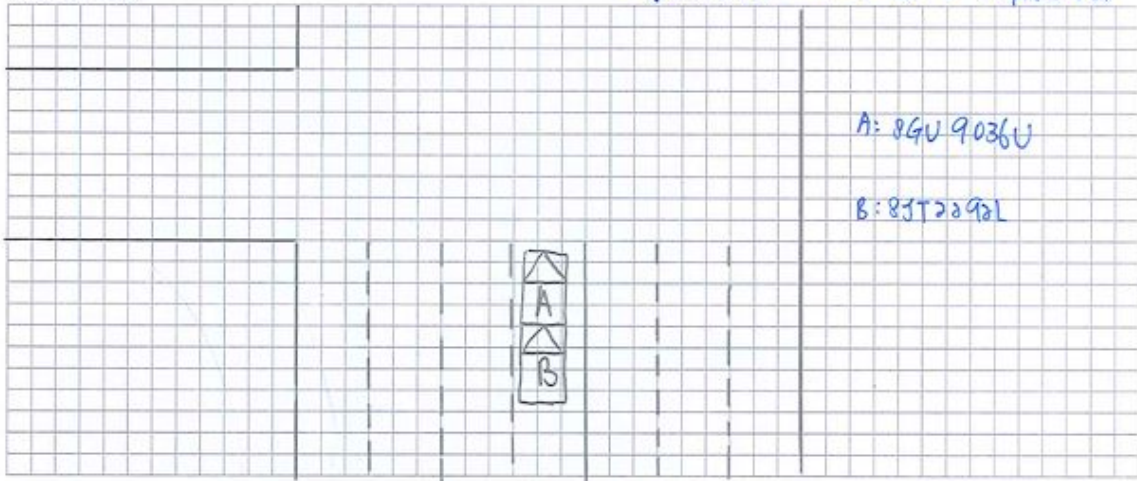
