Details.

On 07/06/2021 at about 1458hrs, I was riding my motorcycle registration plate number JRD7334 along Serivale Link towards Sengkang East Avenue. I was at the T junction after the zebra crossing and I stopped to check for traffic before proceeding onto Sengkang East Avenue. A silver Toyota van registration number 3702B came from behind and moved towards my right side. The said van collided onto my right side and right footrest, causing me to fall to my left together with my motorcycle. The motorcycle landed on my left foot causing me to have injury on my left ankle.
