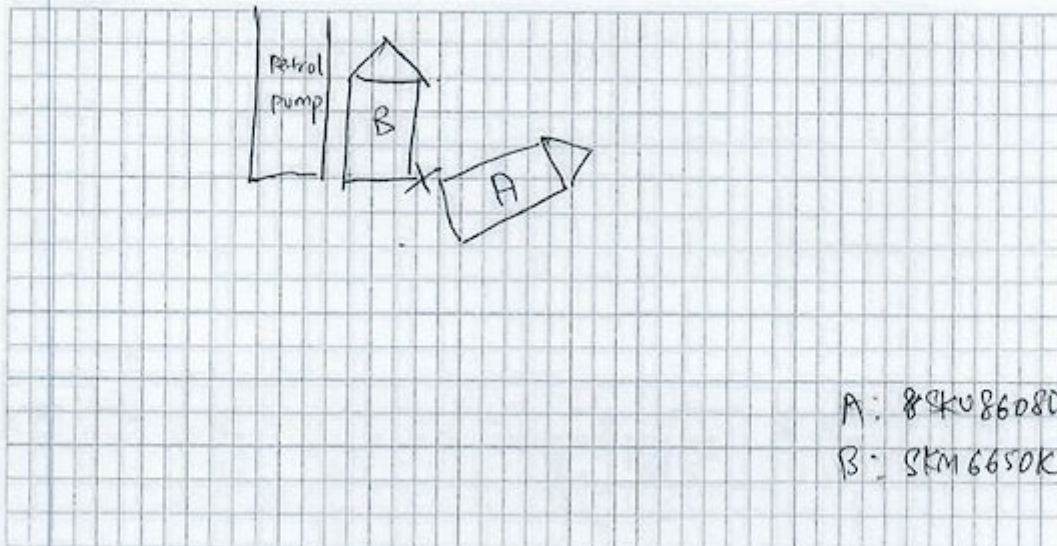

There was no injuries & no one was in the car.


