

CONTINUATION OF REPORT**Brief Details.**

On 29/05/2021 at about 1330hrs, I went to my parked motorcycles near Blk 348 Jurong East Avenue 1. I have 2 motorcycles parked there bearing registration plate FY2739L and FJ283T. When I reached the open space carpark, I saw that there were a few motorcycles toppled to the side and 2 elder persons bringing the motorcycles up. 2 of my motorcycles were also toppled towards the right. I spoke to the 2 persons bringing up the motorcycles and it turned out that 1 of them is the driver that caused the motorcycles to fall down.

The driver said that while he was reversing in the carpark, he hit onto one of the motorcycle and there was a domino effect that caused the rest of the motorcycles to fall as well. No one was injured, no police and ambulance came to scene.
