Brief Details.

On 07/06/2021 at about 0730hrs, I was driving my vehicle bearing plate number: SMQ1265C on the right most lane of KPE/PIE towards Jurong with one passenger onboard. The volume of traffic was moderate at that time when I suddenly noticed the vehicle (SKZ5274B) in front of me had applied its emergency brake. As there was still about 3 car length in-between us, I was able to apply my emergency brake in time and managed to stop before any collision happened.. Suddenly, I felt another vehicle (SLZ7785T) collided with the rear of my vehicle and as a result of this my vehicle rolled in front and my vehicle collided with the front vehicle (SKZ5274B). Due to the impact my air bag was activated. I made a check on my passenger who was conscious however mentioned of feeling pain on his left arm region.

CONTINUATION OF REPORT

I went out of the vehicle to make a check and noticed that the rear vehicle (SLZ7785T) was actually changing lane from the 2nd lane to the most right lane. As a result it collided with my vehicle and another vehicle behind. Based on my observation, there was about 8 vehicle involved in this accident. My vehicle was totally damaged where as vehicle SKZ5274B suffered serious damage to the rear portion and vehicle SLZ7785T suffered serious damage to the front portion. We all took photo and exchanged particulars, soon after both traffic police and ambulance came to scene to render assistance. Based on my understanding, my passenger was conveyed by ambulance as he had difficulties raising his left arm.

I continued waiting for the tow truck to come before I proceed on with my day. However, at about 1100hrs, I start to feel pain on my left wrist and left neck region. I decided to get it check at the clinic and was given 2 days of MC. I wish to inform that I have already provided my SD card to the Traffic Police for further investigation.
