SKETCH PLAN

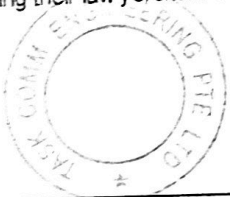

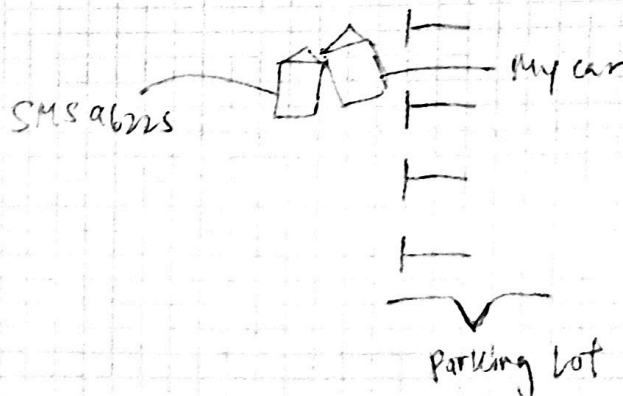

Sketch Plan

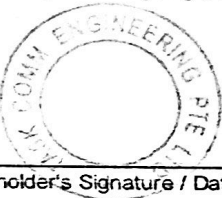
