CONTINUATION OF REPORT

Brief Details.

On 15/06/2021 at about 0945hrs, I was driving my lorry, V5 (YQ2493L) on the second lane from the right of 4 lanes along PIE towards Tuas near Exit 12. As I was driving in slow speed, I noticed that a traffic accident had occurred in front of me involving 4 other vehicles (V1 to V4). As such, I slowed down and managed to come to a stop behind the last car, V4 (SJK7353J) among the 4 vehicles involved in the 4 vehicle chain collision. At this point of time, I have yet to collide with V4. I then signaled left intending to switch to the lane on my left however before I managed to do so, I felt a sudden impact from the rear of my vehicle. Due to the impact from my rear, I then collided with V4 in front of me.

I alighted from my vehicle to make a check and realized that the lorry behind me, V6 (YP5493Y) had collided with my lorry. As such, the accident became a 6 vehicle chain accident. All the vehicles involved suffered varying levels of damage. I am unsure of the cost of repair to any of the vehicles or the extent of damage. From what I remember, none of the drivers had any visible injuries. I am unsure if the other vehicles (V1 to V4 and V6) had any passengers inside the vehicle but my lorry did not have any passengers. After we exchanged particulars, Traffic Police (TP) arrived and I was instructed by TP to drive off in order to not obstruct incoming traffic. I was also instructed to lodge a traffic accident report vide G/20210615/0066.

I wish to state that my lorry possesses in car camera facing the front only however I am unsure if it is in working condition or if footage of the accident was captured. I affirm that as of this report, I am uninjured and I do not feel any discomfort due to the impact from the accident.

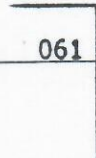
