Thank you for your email.

I had a telephone conversion with your colleague Ms Chew ealier today and would like to emphasize several key points about the accident.


- 1. My vehicle had fully occupied Holland Road and was traveling straight prior to impact.
- 2. I had applied emergency brake and stopped the car immediately on impact from SKV5607X.
- 3. As there was damage to the front axel of my vehicle, I could not drive or steer the car after the collision and exited the car where it had stopped from the collision. Both vehicles could not be moved after the collision and both required to be towed away.
- 4. Both vehicles are well away from the junction box when the accident occurred.
- 5. The collision debris from both vehicles started from next to my front driver's door to the front of my vehicle (see attached image).
- 6. The workshop touts who had showed up soon after the accident had stated to me they were very experienced with such accident cases and know how to make a successful insurance claim on behalf of the driver. The Singapore Police Force has an open investigation on the workshop touts after a post on social media appeared of the same touts. https://m.facebook.com/236169163395908/posts/1589364561409688/?d=n

Please thoroughly review the statements based on the physical facts - I trust your surveyors would find that the claim from the other party would be extremely difficult to reconcile given the final positioning of the vehicles, where the vehicle debris were, and area of damage on the vehicles.

We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, AIG Asia Pacific Insurance Pte Ltd to deal with the third party claim against your policy.

We have received a claim from SKV 5607X against your motor insurance policy.
