

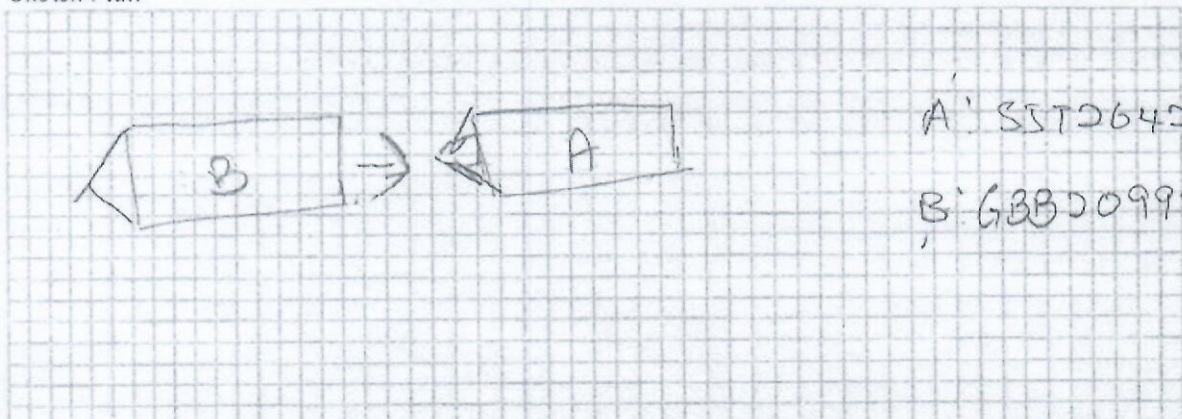

### Sketch Plan






