

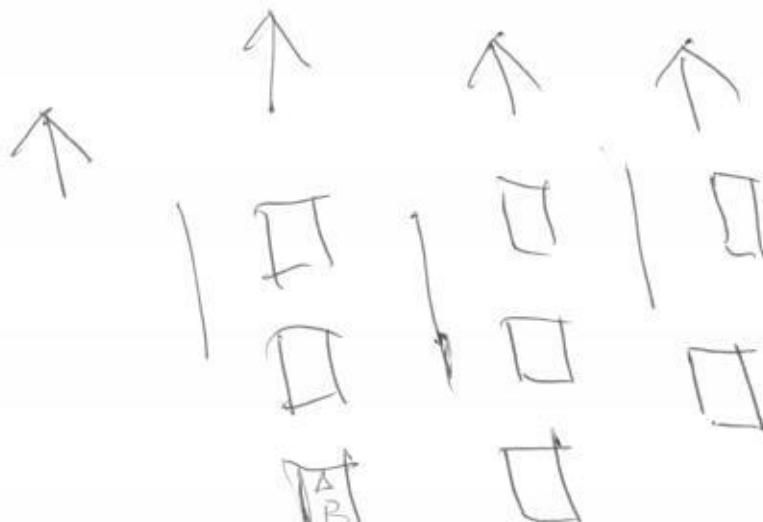
Sketch Plan

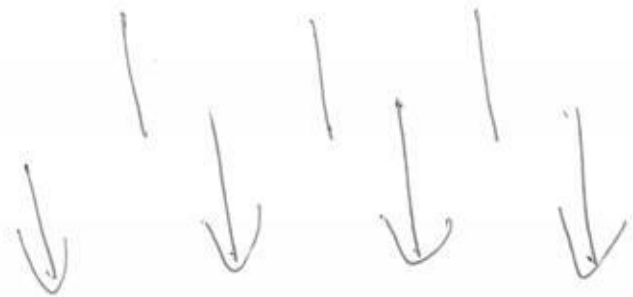
