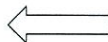
## Letter of Authorisation & Indemnity



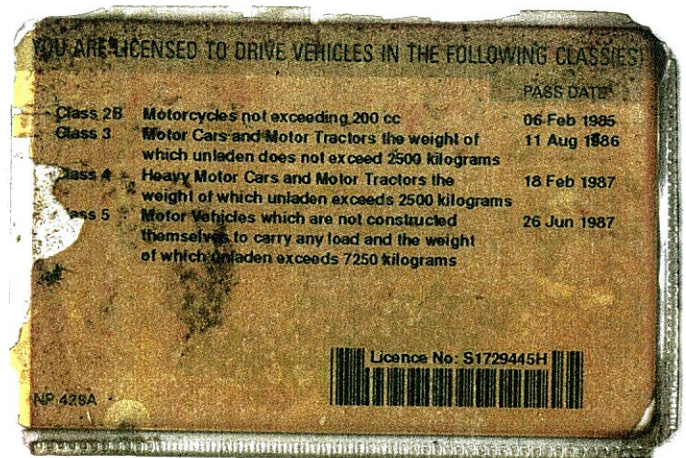
