

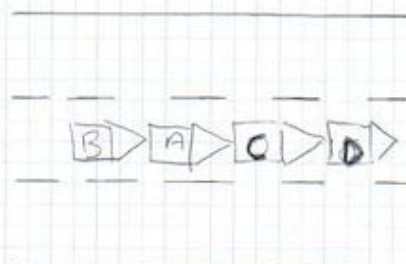

Describe Circumstances of the Accident

On the 23/06/2021 at around 1830hrs, I was driving Vehicle A on DLE Tways before Steven Road exit. I stopped my vehicle behind traffic on lane 2. Suddenly I felt a large impact on my rear, my vehicle lunged forward and hit the car in front of me. I alighted and realised I was involved in a 4 car chain collision. Vehicle B hit onto me. My car lunged forward and hit onto veh C, and Vehicle C had hit onto veh D.
