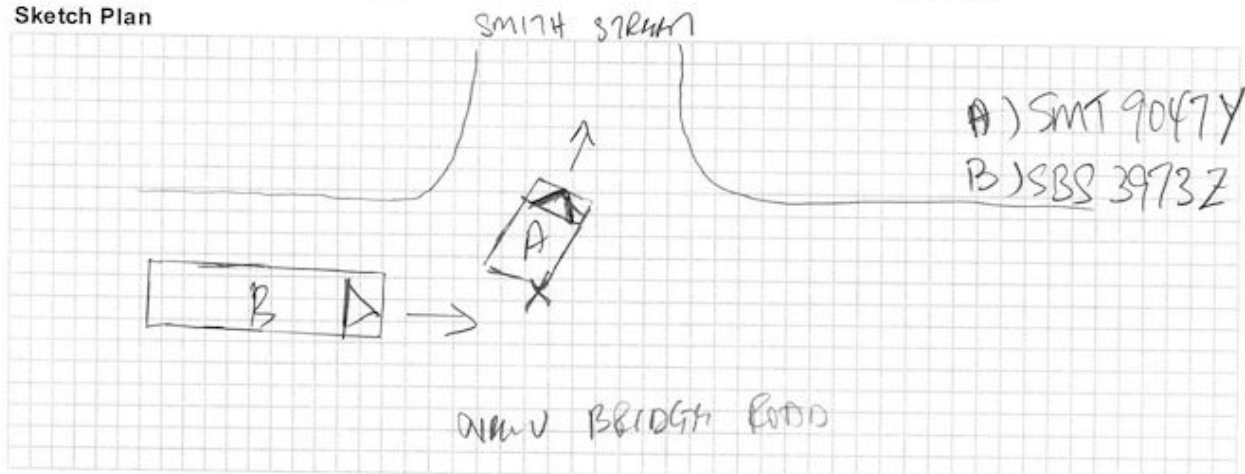

I was driving along New Bridge Road turning into Smith Street when my car was hit at the rear bumper by a moving bus as I was waiting for an opportunity to move forward.

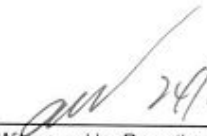
