#### CIRCUMSTANCES OF ACCIDENT

##### REFER TO POLICE REPORT :A/20210622/7005 LODGED AT CENTRAL DIVISION HQ

##### Brief Details

On 22 June 2021 (Tuesday), at about 0830am, I was turning right to Stamford Road (from Nicoll Highway). Upon turning right, I was on the third lane of Stamford Road (lane 1 being the most right lane and there were four lanes at Stamford Road). A red Honda Odyssey (SLW3701C) was on the second lane (i.e. to my right). As the Honda Odyssey wanted to change into my lane, I speed up slightly so as to allow him to change his lane. However, the Honda Odyssey suddenly just cut into my lane and knocked the back of my car (right side). The accident occurred near the Singapore Recreation Club at about 08:31am. I have a dashcam installed on my car and have the available video of the incident. After exchanging details, I noted that the driver is Mr Ho Lam Hwa (driving license no. S1113387H). I am filing this police report for insurance claim purposes.


