
I, Neo Gim Seong (NRIC No. S1718536E) care of NGS Trading, Blk 10 Ang Mo Kio Industrial Park 2A #02-01 AMK AutoPoint Singapore 568047, do solemnly and sincerely make oath / affirm and say as follows:-

- In so far as the facts are within my personal knowledge, they are true. In so far as the facts are not within my personal knowledge, they are true to the best of my information and belief. The documents I intend to refer to in this Affidavit are annexed hereto and marked as "NGS-1".
- 2. I am working as a mechanic and am the sole proprietor of NGS Trading, a car repair workshop situated at AMK Industrial Park. A copy of the

Questnet search of NGS Trading is annexed hereto at pages 5 to 7. I have been in the trade of repairing cars for over 30 years.

- 3. I started repairing the motorcar SFJ 1223T ("the Vehicle") in or around November 2015 when the Defendant first sent the Vehicle to my workshop for repairs, and then I subsequently continued servicing the car over the years. Annexed hereto at pages 8 to 19 are my service records from 2015 up to the time of the accident on 24 July 2017.
- 4. The last invoice dated 27 September 2017 at page 20 is for change of tyres for the Vehicle that was carried out on or about 15 June 2017. The work was invoiced to the Defendant on 27 September 2017 as my tyre supplier Stamford Tyres had only invoiced me for the tyres on 21 September 2017. Annexed hereto at pages 21 and 22 are the said invoice as well as delivery order from Stamford Tyres.
- 5. I was informed by the Defendant sometime after the accident that on 24 July 2017 that the Vehicle had suddenly lost power and stalled while being driven on the highway. There was thereafter an accident where the Plaintiffs had collided into the Vehicle.
- 6. The servicing maintenance and repair of the Vehicle over the years did not show any reason for which the Vehicle would have stalled. I do not know what caused the Vehicle to stall.

7. I did not service the Vehicle after the accident. I understand from the Defendant that the Vehicle had been compounded by the traffic police and thereafter sent to another workshop, before the Vehicle was scrapped.
