SUPPLEMENTARY AFFIDAVIT OF EVIDENCE-IN-CHIEF
OF ANG ZHIQIANG

I, ANG ZHIQIANG (NRIC No. S8331354D) of 32 Lorong Tanggam Singapore 798732, do solemnly and sincerely make oath / affirm and say as follows:-

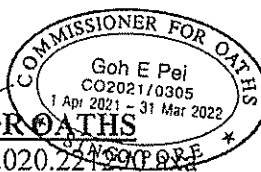
1. I am the Defendant herein.
2. In so far as the facts are within my personal knowledge, they are true. In so far as the facts are not within my personal knowledge, they are true to the best of my information and belief.
3. I crave leave to refer to my Affidavit of Evidence-in-Chief ("AEIC") filed on 17 March 2021.

4. I understand from my lawyers that the Plaintiff has since amended his Statement of Claim and raised the point about warning lights. I therefore now make this Supplementary AEIC to address this point.
5. Further to paragraph 7 of my AEIC, the time frame between the moment I realised there was a sudden loss of power in the Vehicle to the moment the Vehicle stalled was short.
6. When I realised that there was a sudden loss of power in the Vehicle I signalled left as I wanted to make my way to the road shoulder. During this period, I did not notice the Vehicle's dashboard as I was concentrating on the traffic on my left. I therefore did not notice any warning lights or warning sounds from the dashboard.
7. I realised that with the Vehicle's loss of power it would not be able to cross to the road shoulder especially with vehicles also travelling on the left. I immediately turned on my hazard light and just then, the car stalled.
8. I tried to restart the Vehicle but it did not start. I pressed the boot switch to release the boot where my triangle break down signage was kept and opened the door. The accident then occurred.
9. After the accident, the paramedics told me to move the Vehicle. I told the paramedics that the Vehicle does not work, but that I would try. I then tried to start the Vehicle and successfully did so. The usual lights on the dashboard turned
