I WAS TRAVELLING ALONG KJE ON THE RIGHT MOST LANE OF 4 LANES. AS I WAS TRAVELLING STRAIGHT, SOMEWHERE NEAR EXIT 7, M/CAR (SMH5396D) IN FRONT BRAKE AND STOP. I ALSO APPLIED MY BRAKE TO STOP WHEN SUDDENLY, ONE M/CAR (SGC8888D) CAME FROM MY REAR AND COLLIDED ONTO THE REAR PORTION OF MY VEHICLE. DUE TO THE STRONG IMPACT, CAUSED MY VEHICLE TO SURGE FORWARD AND HIT ONTO M/CAR (SMH5396D) IN FRONT OF ME. AFTER THE ACCIDENT, I CAME OUT OF MY VEHICLE AND REALISED A TOTAL OF 4 VEHICLES INVOLVED IN THE ACCIDENT.



I WAS TRAVELLING ALONG KJE ON THE RIGHT MOST LANE OF 4 LANES, AS I WAS TRAVELLING STRAIGHT SOMEWHERE NEAR EX77, M/CAR SMH 5396D IN FRONT BRAKE AND STOP AND I ALSO APPLIED MY BRAKE TO STOP WHEN SUDDENLY, ONE M/CAR S6L 0888D CAME FROM MY REAR AND COLLIDED ONTO THE REAR PORTION OF MY VEHICLE, DUE TO THE STRONG IMPACT CAUSED MY VEHICLE TO SURGE FORWARD AND HIT ONTO M/CAR SMH 5396D IN FRONT OF ME.
