Vehicle registered in 2010 and its COE was extended till 2024. COR recommended is \$3,550/-.

Internally, we have SOP to check the MV for all cases however we will only indicate the MV in SR if the repair cost is above specific range and/or if the vehicles are nearing the end of their COE lifespan regardless of whether insurer request. There are also insurers who had previously given us standing request to indicate MV in the SR for all their cases and so far, BDI is not one of them.

If you require the MV for all BDI cases, please advise and I will pass down the message to my colleagues to indicate the MV in SR henceforth.
