**Brief Details.**

On 06/03/2020 at about 0850hrs, I was driving my vehicle SLP4487B along Upper Jurong Road. I was on the merging lane towards PIE. As I was driving, there was a SMRT taxi SHC4401P which was in front of me. The taxi driver had applied emergency brakes and I immediately applied mine as well, and was able to avoid collision at that point of time. However, one Malaysia tipper truck JEG6200, which was behind my car collided with the rear of my vehicle, causing me to inch forward and collide with the front taxi.
