Brief Details.

On 06/03/20 at about 0850hrs, I was driving my SMRT taxi SHC4401P along Upper Jurong Road towards PIE. I was on a merging road and the traffic was slow moving. As I wanted to create distance with the vehicle ahead of mine, I applied my brakes. I then felt an impact coming from the rear of my vehicle. I then noticed that one Singapore registered vehicle SLP4487B and collided with my vehicle. I was then told by the driver that he was able to brake on time however, one Malaysia tipper truck JEG6200 had collided with his rear, causing him to inch forward, causing the collision to my taxi.

No one was injured due to the impact and there is a front in-car camera installed in my vehicle
