Please process settlement in sum \$ 3050.00 to resolve our property damage claim amicably.

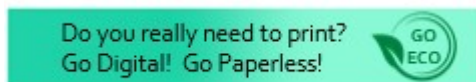
Furthermore, it is a condition of any settlement reached that it shall be without prejudice to any personal injury claim (if any) of the taxi driver and/or passengers.
