Vehicle SLF 3483X is in front of the vehicle GM1878X. The latter vehicle number is driven by me Tan Song Ping. Heavy rain have just subsided. Both the vehicles were at the signal junction along Yishun Ave 9 towards Yishun Central road. Both vehicles were at the 1st lane going to make a right turn when the signal start to turn green. Vehicle SLF 3483X make a stop in front of the pedestrian walkway for the pedestrians to cross. I fail to see the pedestrians that are crossing the road in front of vehicle SLF 3483X and the brake lights of the vehicle SLF 3483X looks the same from moving to stop position. I was a bit too near to the vehicle SLF 3483X that I cannot brake in time to avoid crashing to vehicle SLF 3483X left side to rear bumper.

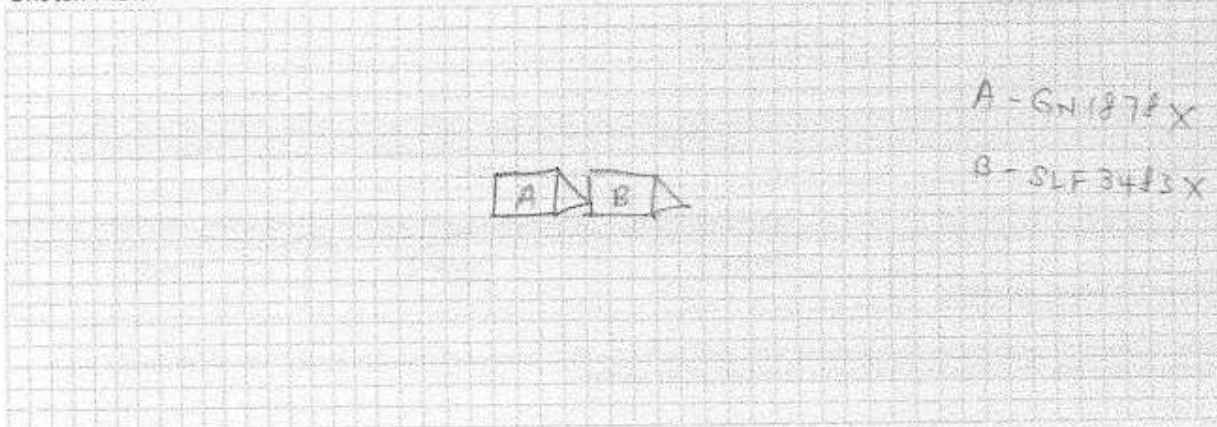
