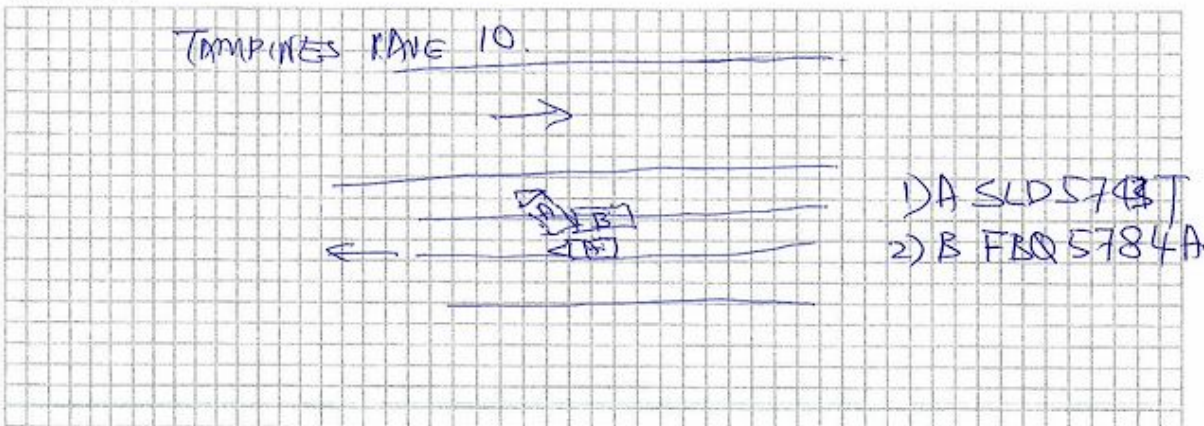

Sketch Plan

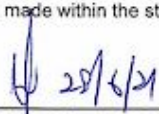
Describe Circumstances of the Accident

 That all.

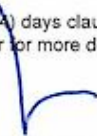
