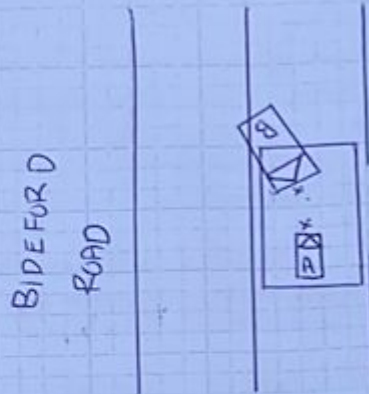

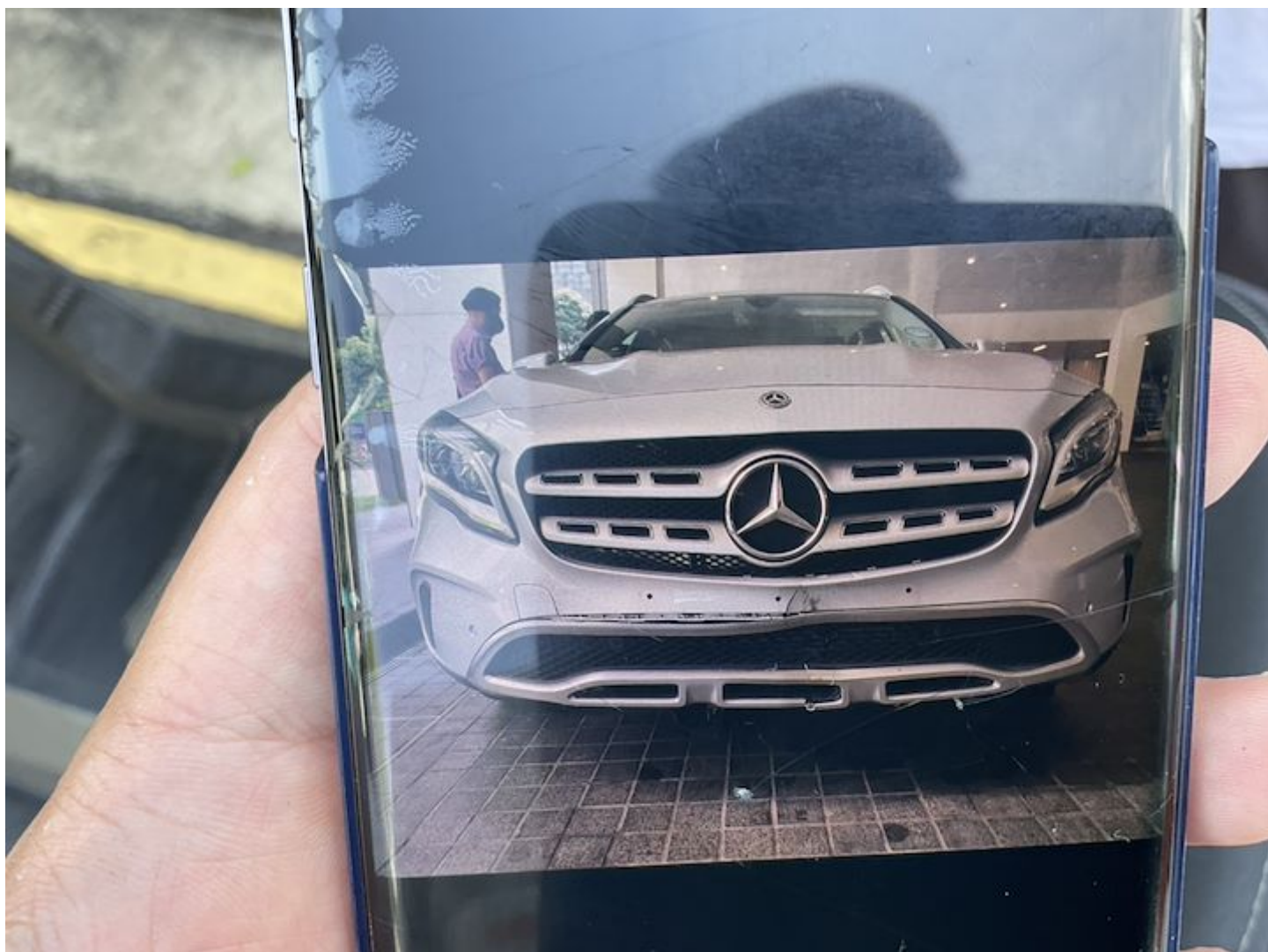

On the 16th June 2021 at 1513 hours, I was on my ways to collect a delivery order. I was riding a motorbike (FBM 3975A). I was the only vehicle riding on my lane.
