CIRCUMSTANCES OF ACCIDENT

ON 3 JULY 2021, AT APPROXIMATELY 12:15PM, I WAS ATTEMPTING TO MAKE A LEFT TURN FROM TOH TUCK TERRACE INTO TOH TUCK ROAD. THERE IS SOME ON GOING CONSTRUCTION WORK TAKING PALCE ON THE LEFT HANDSIDE OF TOH TUCK ROAD. I STARTED TO MAKE MY LEFT TURN AS ANOTHER VEHICLE WAS TURNING RIGHT FROM TOH TUCK ROAD INTO TOH TUCK TERRACE , FOLLOWING BEHIND ANOTHER WHITE SEDAN THAT HAD ALSO TURN LEFT. AS I WAS ABOUT TO COMPLETE THE LEFT TURN, A YELLOW HATCHBACK (SMH 9812 T)SPED PAST ME, THE FRONT OF MY VEHICLE SCRAPPED HIS SIDE. WE IMMEDIATELY STOPPED OUR VEICLE ALONG TOH TUCK ROAD AND EXCHANGED PARTICULARS AND VIDEO.



There is some on going construction ~~going~~ work taking place on the left hand side of Toh Tuck Road.


