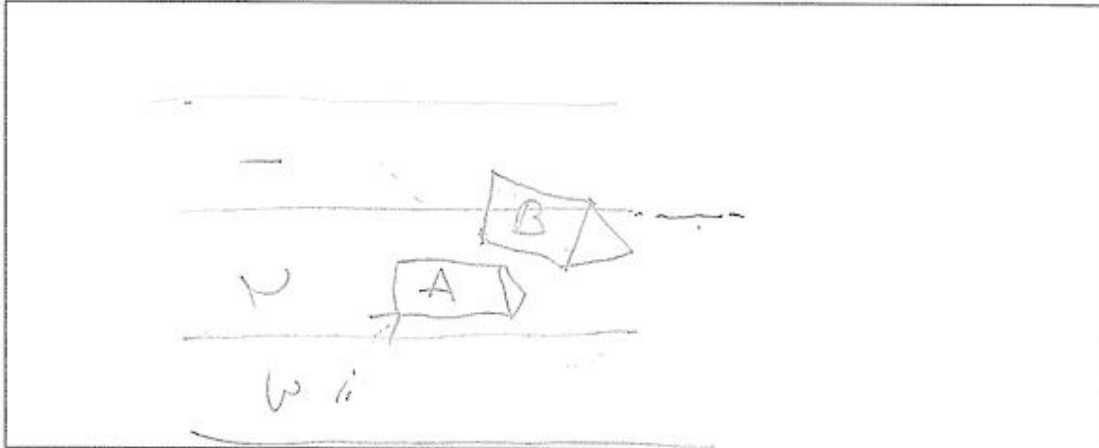

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 5/7/2021 around 1145hrs, SLU 754 E travelling along Toh Tuck Ave toward Boon Lay.

I was travelling on the extreme right lane. Then I change lane to lane 2 as there is a vehicle stop on the extreme right lane. After my vehicle fully enter into lane 2, I saw vehicle B trying to cut into my lane from the extreme left lane (1). I subsequently hit its left rear bump onto my front left while cutting in my lane.
