Dear Ms. Joane,

Thank you for sharing the update. Please see attached photos taken after the impact, of both my vehicle and the said vehicle SMX8579P.

As shown, there is minimal sign of damage on my vehicle and SMX8579P, it is with doubt that this kind of impact could have resulted in any injury for the driver in front. For your necessary review and assessment. Moreover, my impact did not cause her to impact the car infront of her as you can see the images taken of her vehicle and the vehicle SKX6919D infront of her. During the conversation between driver of SMX8579P & driver of SKX6919D, she also claimed to not have impacted SKX6919D.

I would also like to share my dashcam footage after the impact. Please see below attached google drive link for downloading the video. The driver of SMX8579P does not seem to have sustained any injury as we proceed to assess the damage, she was walking as per normal and did not show any signs of being injured. I did check with her verbally immediately after the impact, she said she is fine and no injury. Unfortunately, the footage during impact was corrupted so I am unable to recover and share the file. The only available footage was after the impact when we stopped by the side.

One important observation I would like to highlight is that shortly after the collision when all vehicles parked at the side, at least 2 unidentified individuals who were not involved in the accident showed up to the scene. They seen conversing to all the affected drivers infront except me. The conversation should be captured by the rear dashcam of SMX8579P as they were standing in between my vehicle and SMX8579P. Time frame should be between 9.20PM – 9.55PM.

I overheard from their conversation it was a series of questions regarding the accident:

- Are you a PHV driver
- Is your vehicle rented or your own
- Some other questions relating to the accident and follow up action

I am in doubt about the authenticity of the accident as these individuals showed up almost immediately after the impact. Based on my recollection, one was of slim body build, wearing black t shirt, jeans and sneakers, no spectacles. He was observed to be conversing to each and every driver involved in the accident.

As you are part of the investigative body on this case, I humbly request for you to look into this with utmost importance. The dashcam footage (front & back) of SMX8579P holds important information to support my above mentioned claims. Please try your best to get hold and review the said footage. On the next morning, I politely requested SMP8579P's driver to share the footage with me but was rejected as advised by her insurance agent. I believe as an authorised investigative body, you will be able to request for the footage officially.

Lastly, I would like to declare that all the above information provided by me are correct to the best of my knowledge and understand the consequences of providing any false information. I look forward to your greatest assistance in this case for me.
