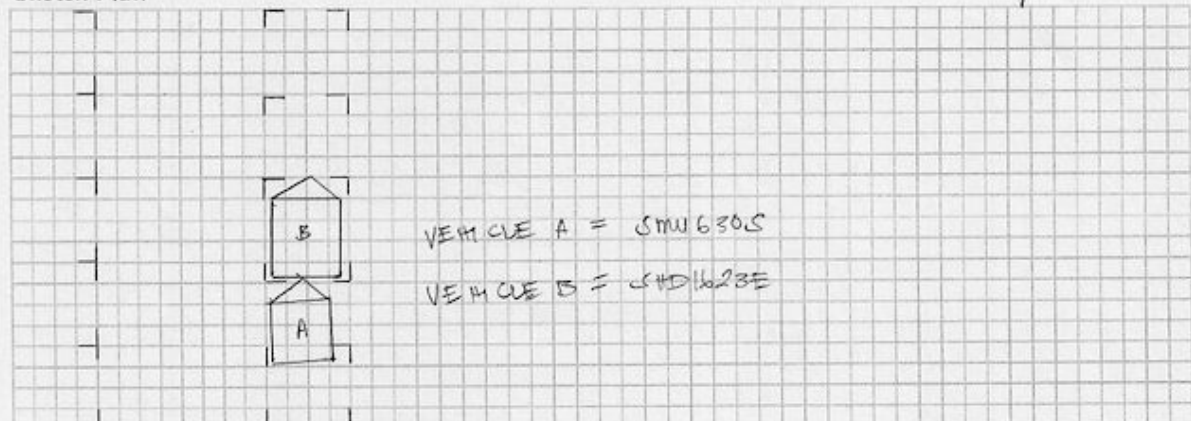

Describe Circumstances of the Accident

I then called the police & they said that since no one was hurt & no damage to public property, no need for report.


After that, I called my ins. carrier & gave them the same details & they said to go to CTC & UBI to make a report.

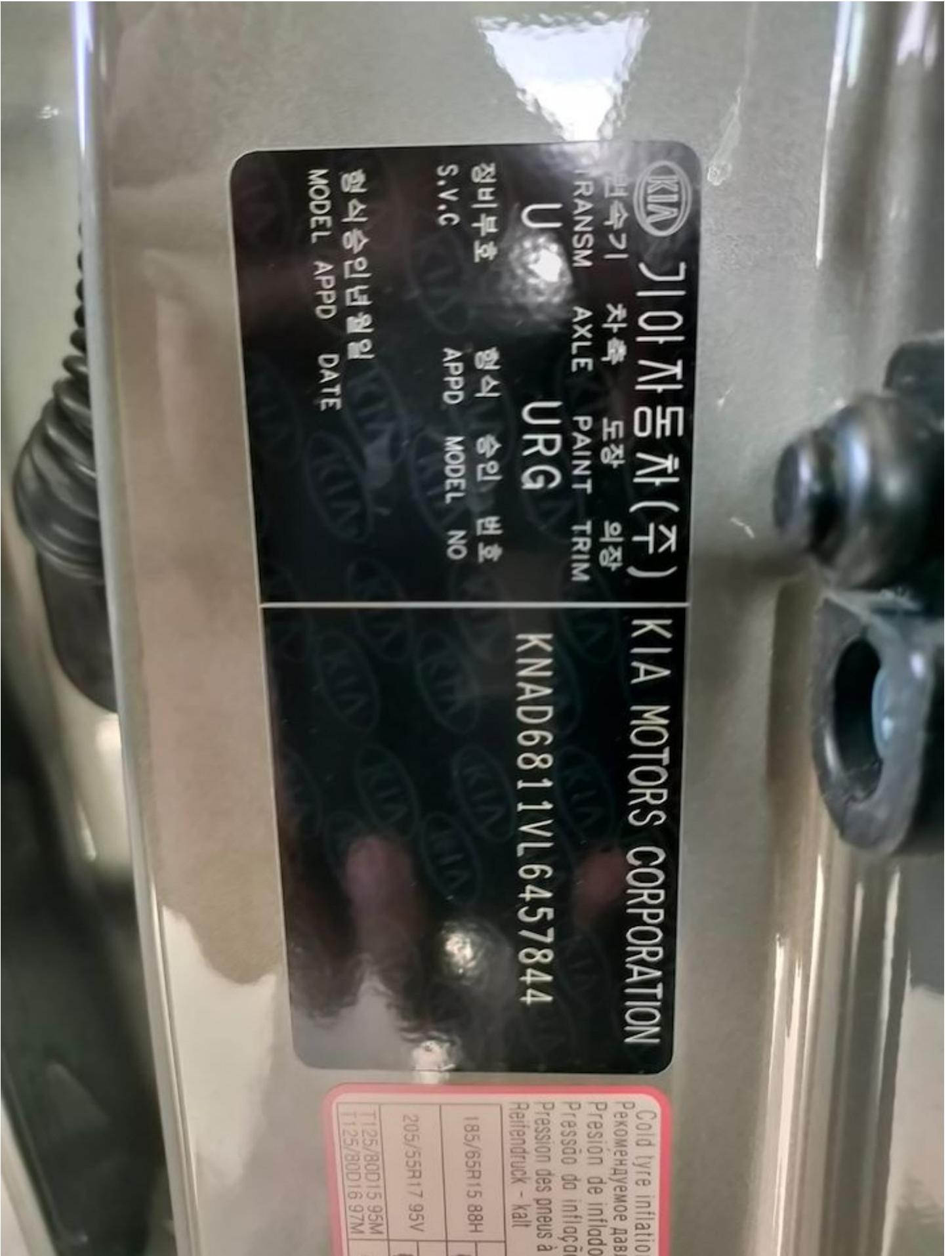














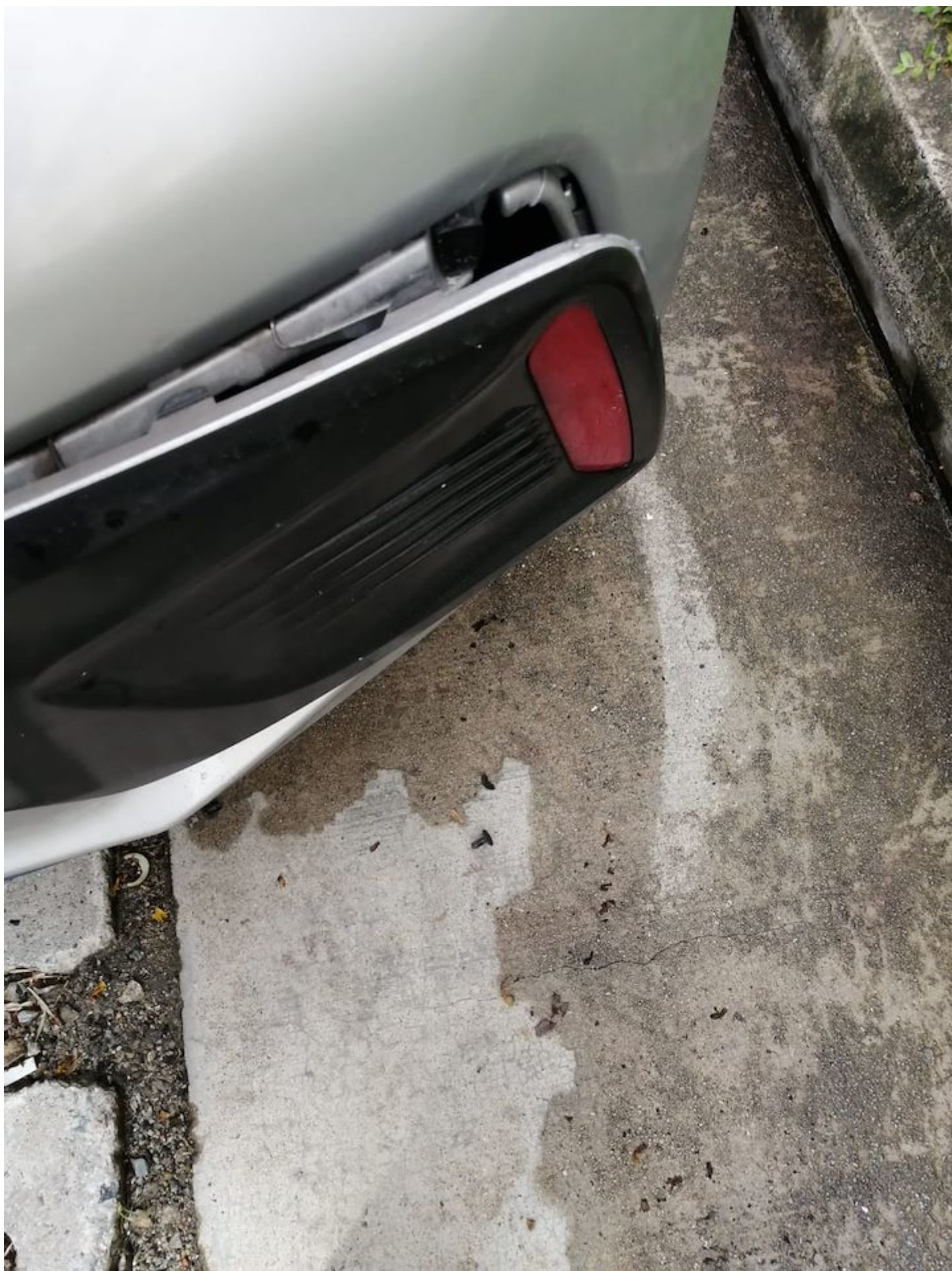
