

**Describe Circumstances of the Accident**

My car was in a stationary position at the u-turn road to Stevens Road towards the direction of Scotts Road. AS I was waiting for oncoming vehicles to clear, I felt an impact from behind. Upon alighting, I found a car bearing no. SJP 5888Y had collided onto the back of my car. Both of us exchanged particulars and the driver of SJP 5888Y also wrote a note admitting his fault. I wish to state I have an in car camera that has captured the whole accident. A few hours later, I felt discomfort around my back, <sup>shoulder area</sup> and subsequently went to see a doctor. I was given 2 days of MC.
