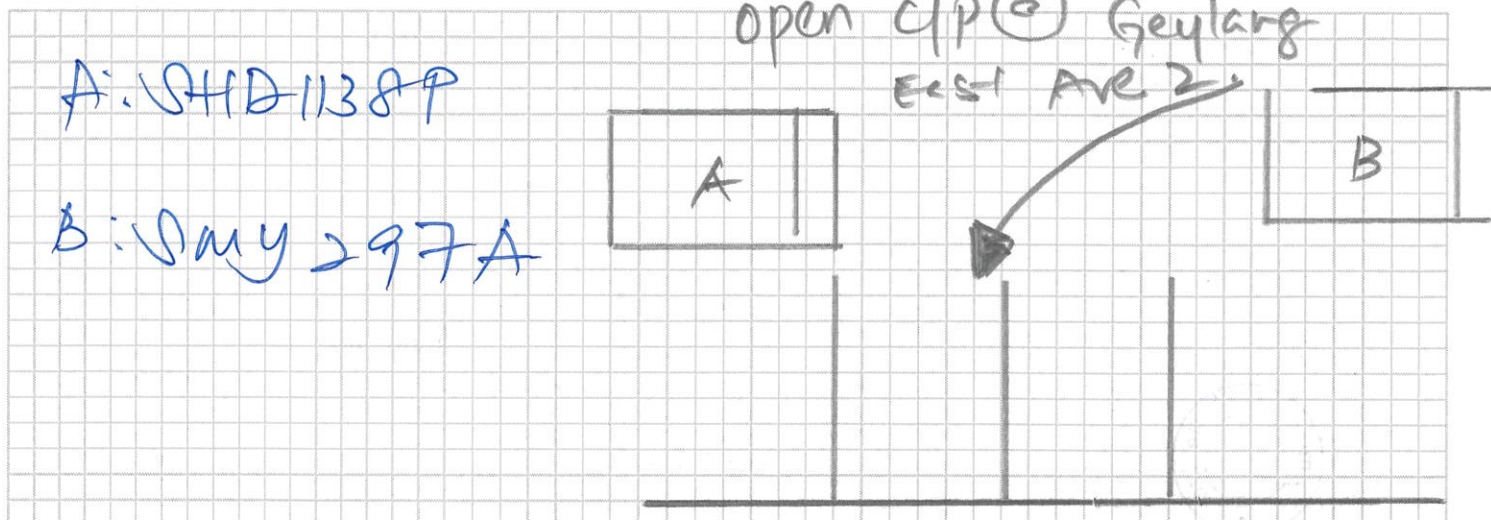

WAS IN FRONT OF ME, STOPPED.

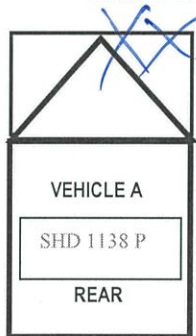
WHILE STATIONARY, SUDDENLY VEHICLE B BEGAN TO REVERSE ABRUPTLY (INTO

VEHICLE B HAD DAMAGES ON THE LEFT PORTION.

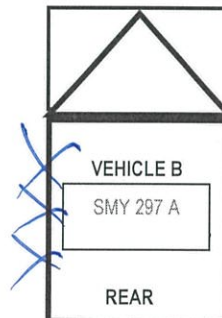
