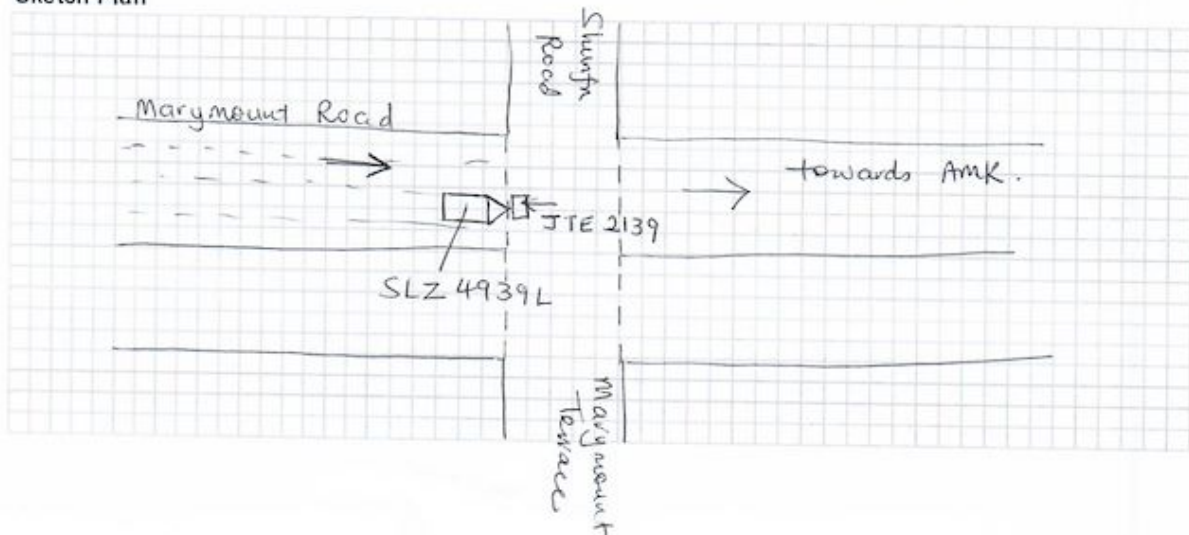

## Describe Circumstances of the Accident

On 16 Jul 2021, at 0028hrs, I was driving home from work and stopped at the red traffic lights of Marymount Rd, at the cross junction with Shuntan Rd, heading towards Ang Mo Kio. I spaced out momentarily as I was exhausted. While stopped, a traffic light further down the road turned green, and I accidentally reacted to that, although my traffic light was still red.

As I moved off, I crashed into the back of a black motorcycle stopped in front of me that I had not noticed before. I stopped on impact but by this time, the back wheel of the motorcycle had become stuck under the front of my car.

The rider and his pillion were able to hop off the bike in time, and did not seem to have any obvious injuries. I did not sustain any injuries as well. Traffic Police was called to scene as the motorcycle was Malaysian-registered, and the two vehicles could not be separated from each other. Therefore, the vehicles were also still blocking the road. This was done while awaiting for the tow truck to arrive.

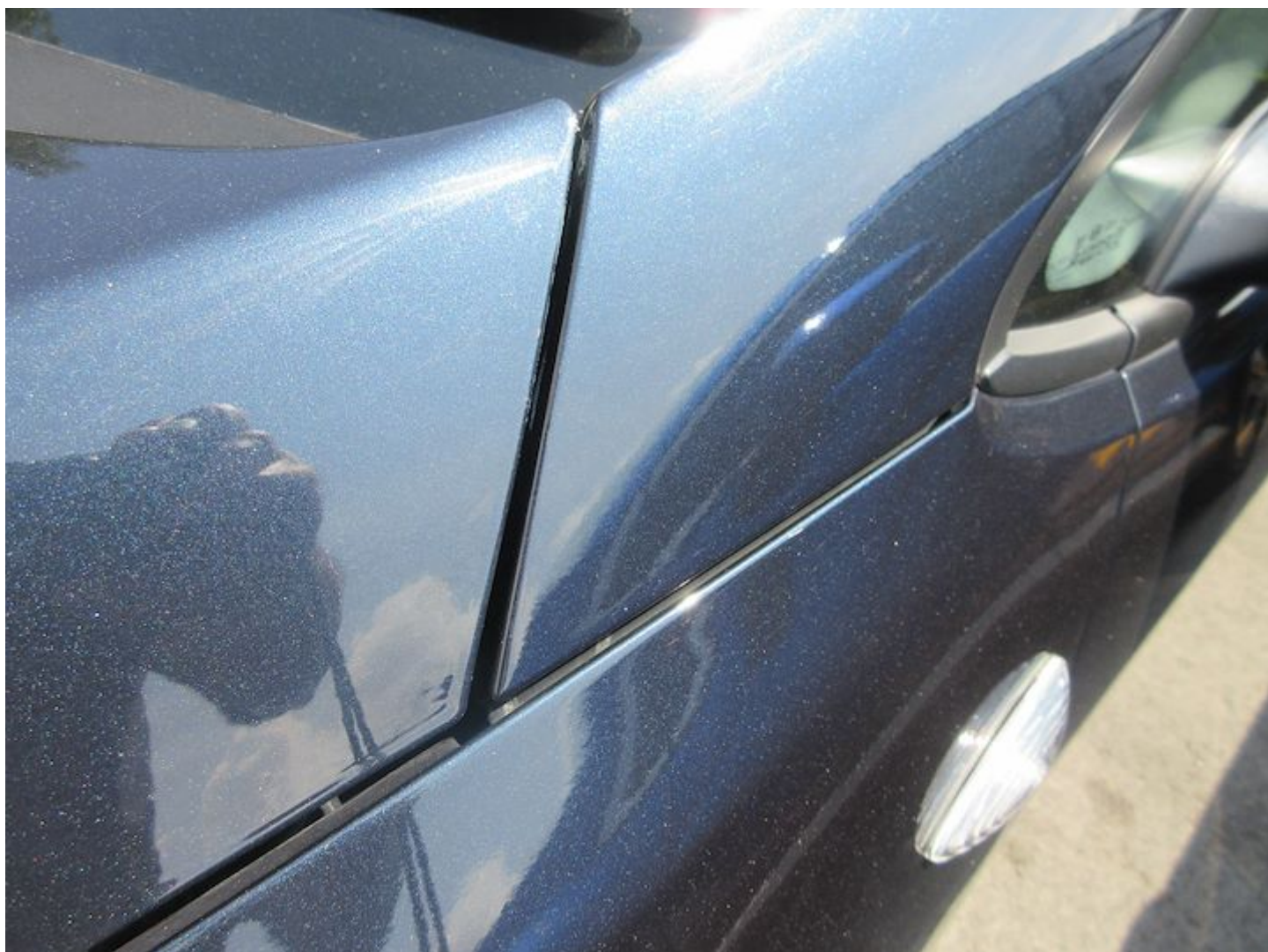






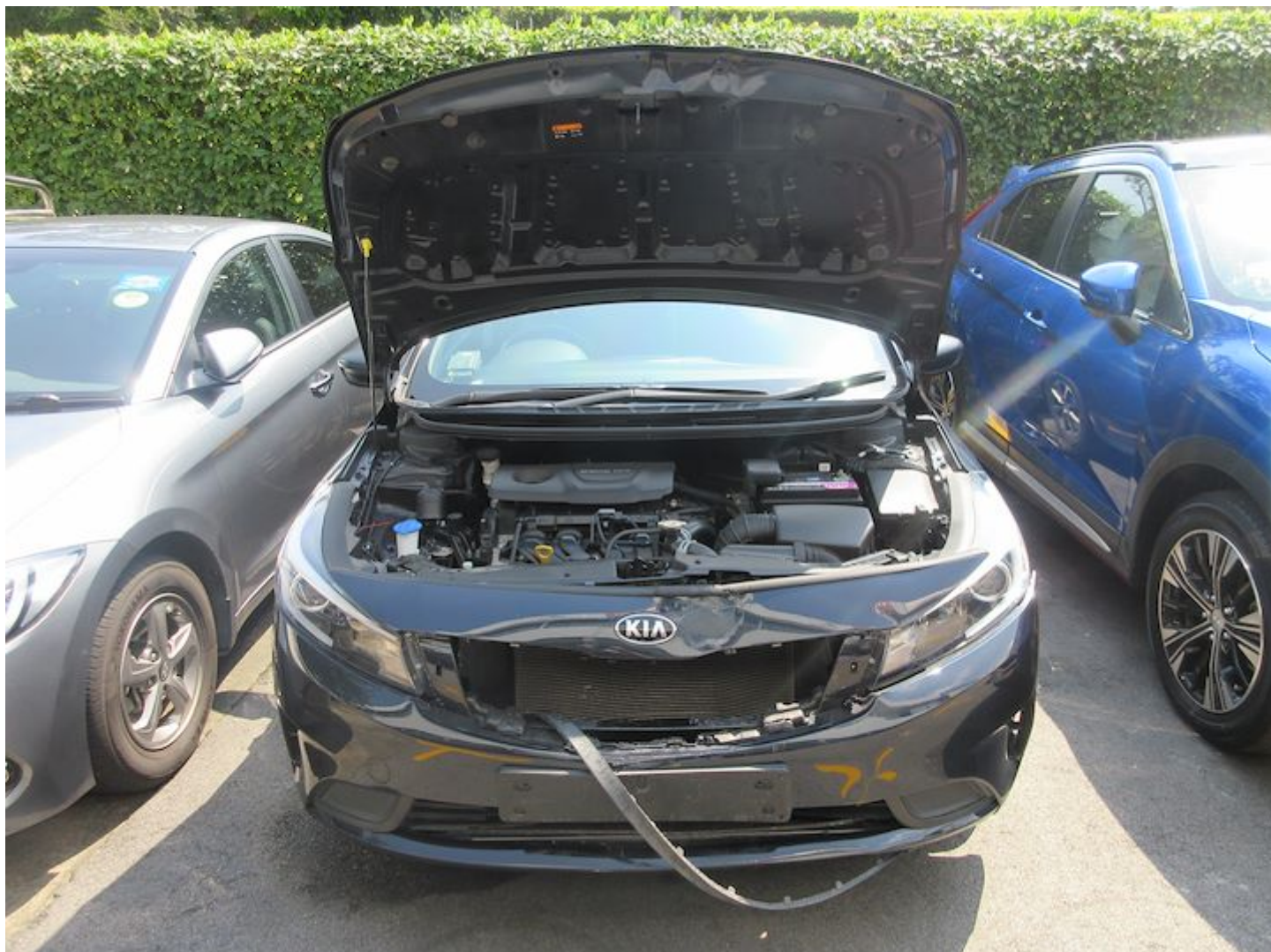

**Brief Details.**

On 16/7/2021 at about 0028hrs, I was driving my vehicle (SLZ4939L) along Marymount Road towards Ang Mo Kio Ave 1 direction. When the traffic light at the cross junction of Marymount road and Shunfu road turned red, I slowed down my vehicle and came to a stop. As I was feeling exhausted, I recalled that I spaced out for a while. I did not notice that the motorcycle (JTE2139) stopped in front of my vehicle (SLZ4939L). Shortly after, I noticed that a traffic light turned green, so I moved off and collided head-to-rear into the motorcycle (JTE2139). I stopped my vehicle upon experiencing the impact of the slight collision. At that point of time, I realised that I had accidentally reacted to the green traffic light ahead of the current traffic light as the current traffic light was still red.

Subsequently, I noticed that the rear wheel of the motorcycle (JTE2139) got stuck under my vehicle front bonnet. Both the rider and pillion of the motorcycle (JTE2139) were able to hop off their motorcycle. However, we were unable to move the vehicles. I did not observe any visible injuries on both the rider and pillion, but they informed that they may be seeking medical consultation after the accident. I also did not sustain any injury. As both the motorcycle (JTE2139) and my vehicle (SLZ4939L) were stuck together, we called for traffic police assistance. The traffic police came to scene and provided me with a case card vide E/2210716/0007, Traffic police IO Wei Li, Contact number 65476394. Lastly, we engaged a towing crew to shift the vehicles away. My vehicle does not have a working in-car CCTV.

After the accident, I observed that my vehicle (SLZ4939L) front bonnet was badly damaged, the vehicle registration plate dislodged, and there was radiation fluid leakage.

I am lodging report as instructed by the traffic police.
