

SKETCH PLAN

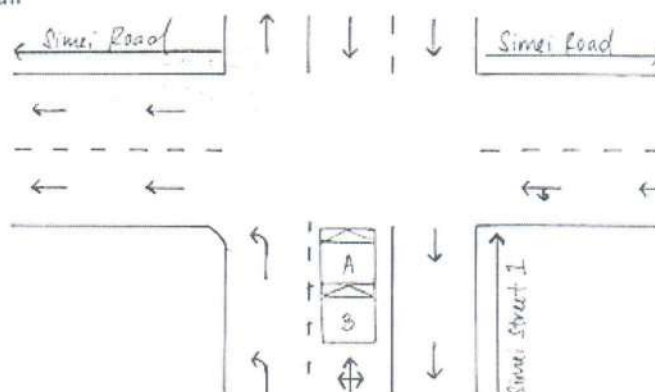
