**Brief Details.**

On the 12/07/2021 at about 4.15pm, while I was riding my motorcycle along Telok Paku Road towards cargo. I was on the right most lane. When I was approaching the slip road which was near to the Changi Beach Carpark 2, suddenly there was a car that came out from the slip road wanting to cut into the opposite direction lane. This car suddenly stopped in between both direction lanes and in the middle of the road as there were incoming vehicles from the opposite direction. I tried to apply emergency brake, however hit onto the right side, rear door of the car. I fell off from my motorcycle.

The driver of the car came to attend to me and apologize. His car had scratches and dents on the right rear door, and my motorcycle was totally damaged on the front part and could not be ridden. The driver then offered to send me to CGH and I was given 3 days MC.

My right elbow, right leg thigh and left leg ankle was injured.

The driver is the car's Indian Muslim Uncle in his 70s, hp: 96604201.
