

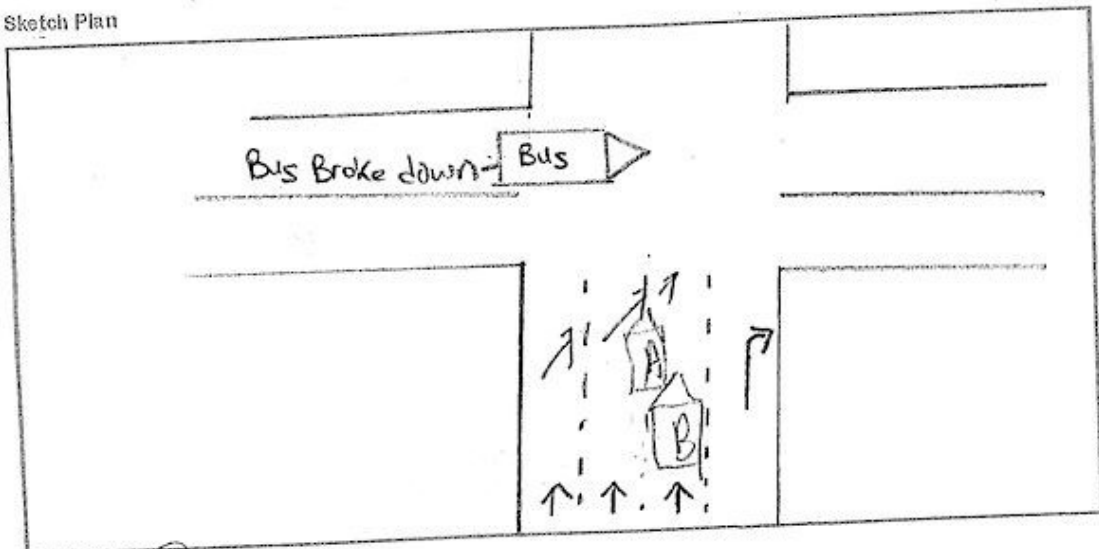

Describe Circumstances of the Accident.

2/7/21 8.45pm My vehicle along Sembawang road in front of junction of GRAMBAS Ave, there is a Bus Blocking LANE 1 & 2 from left, only LANE 3 can be use, in front car & side car all diverting to LANE 1 to pass through the junction. I am at LANE 2 also following very slowly. Diverting to LANE while stopping at LANE 10. Back car SMP 3807G suddenly just move very slowly forward & brush against my back left tyre side causing scratches. I take pic & left by driving forward but no site of back car can be seen.
