We refer to the above matter.

TP reported that he was travelling along New Bridge Road towards Kampong Bahru on the most left lane. When he was travelling near to Chinatown point, suddenly OI changed into his lane from the right and hit onto TP's taxi.

OI reported that he slowed down with his left indicator on before he filtering into the bus lane. OI noticed that TP who was exiting from Chinatown Point, stopped and gave way to him(giving hand signal to proceed). While OI was filtering into the extreme left lane, suddenly he felt an impact from his left and discovered that TP moved off ahead and hit him.

TP submitted a copy of the video footage for our consideration. (A copy of the video will be sent to your good office by next week). The video footage shown that TP was exiting from minor road and collided with OI who was changing lane from the right to left on main road as resulted the collision. We are of the opinion that TP should exercise greater caution while turning out from minor road.

In view of this, we are intending to reject third party claim.
