

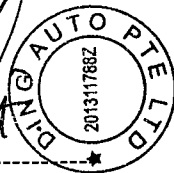

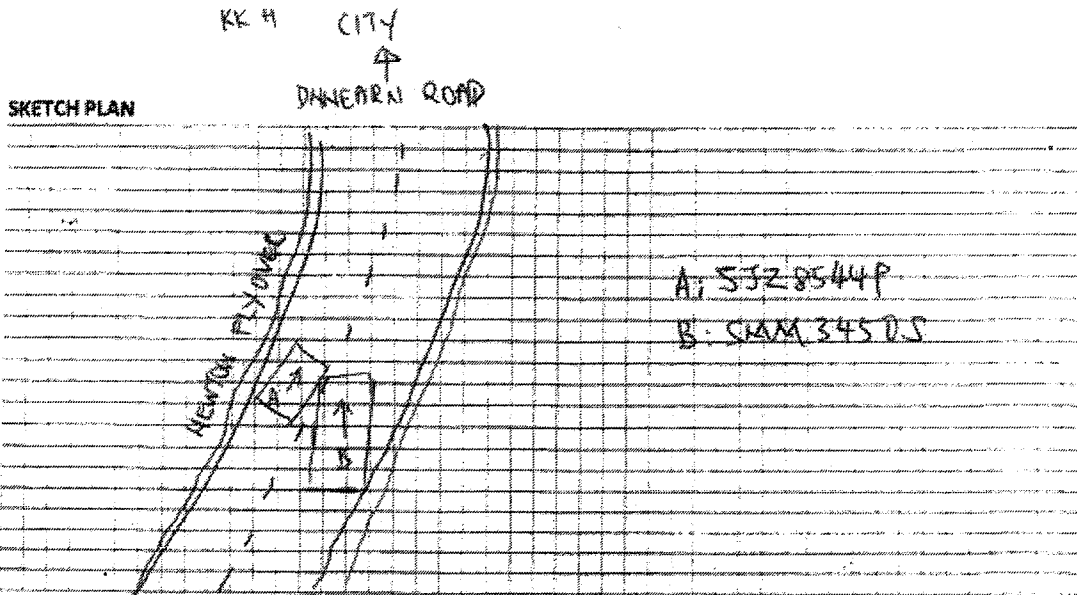

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was sending a customer to Pickson Road.

One passenger (name: Soh Yeon) was in my car. She is my witness.

At Whitley Road join (left turn) Dunearn Road, from my right side mirror, I saw vehicle B drove across Double White Lines to join Dunearn Road. Both vehicles were travelling towards Bugis direction.

At Dunearn Road (Newton Flyover), I was changing lane from lane 2 to lane 1. Suddenly vehicle B ^{speed and} crashed into the right side of my car and subsequently stopped 50m ahead. Vehicle B speed up suddenly. My passenger/witness felt her neck/spine unwell.

Discussion with vehicle B driver is unfutile and there was a 3rd party person (parked car SGU 3097H illegally on Dunearn Road and smoked out of yellow box).

While attempting to exchange particulars, vehicle B driver suddenly accused me of not having a driver licence and refused to exchange. Only after EMTs personnel arrived, then driver particulars can be exchanged.

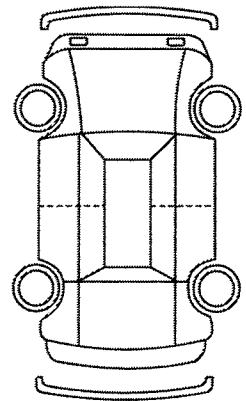



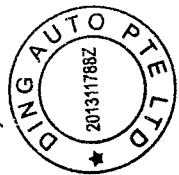
