Brief Details.

On 16/7/2021 at around 1400hrs, I was riding my Malaysian motorcycle, one black and white Yamaha LC135 (registration plate number: JSC1804) on the first lane along PIE towards Jurong (before Paya Lebar exit). When the traffic became congested, I applied my brakes and my motorcycle came to a stop on the first lane. Suddenly, my motorcycle was hit on its rear by another motorcycle, one grey Kawasaki (registration plate number: FBS741K) and due to the impact, the said motorcycle also hit onto one black Toyota Vios (registration plate: SKB4347H) that was stationary on the second lane. After the accident, I did not exchange particulars with any of the involved party as I was unsure of what to do as it was my first time getting into an accident. I then went to Joy Family Clinic at Blk 703 Bedok Reservoir Road and was given 3 days of medical leave. I am lodging this report to seek police assistance.
