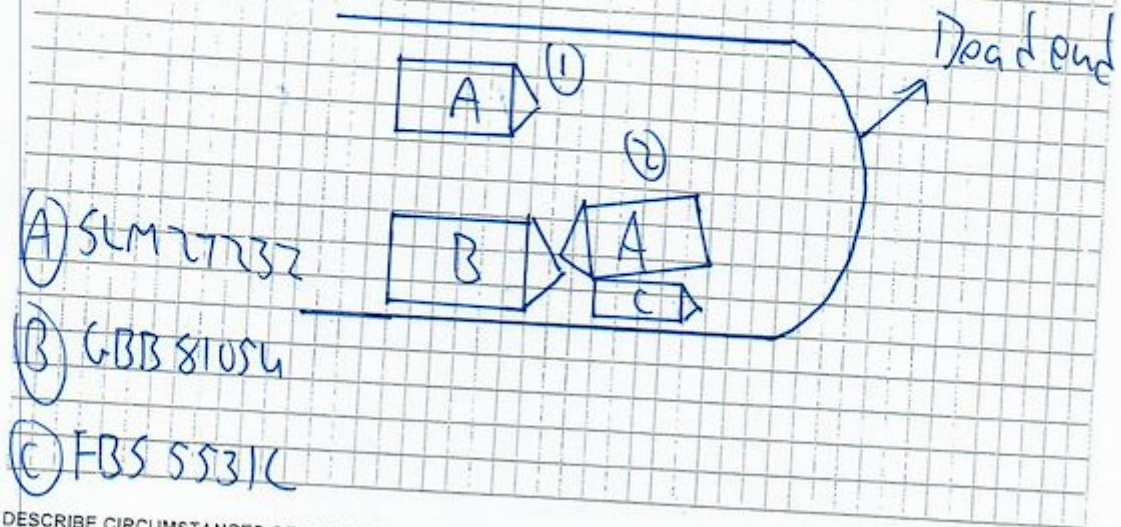

ON 16 JUL 2021 AT 13:00 53 SIXTH AVE SINGAPORE 276491

On Friday, 16 Jul 2021, I was driving along Sixth Ave. I did a U-turn and inadvertently knocked a motorcycle FBS 5531C and a van GBB 8105U which were parked on the right side of the road as the space was narrow.

Both vehicles were stationary at that time and no one was injured. I stopped my car, SLM 2723Z and came out to have a look. The owners of both vehicles by then also came out to check.

After assessing the situation with drivers of both the motorcycle and van we exchanged details of our driving licenses. The motorcycle had landed on the ground. Visually, we did not see any physical damage. However, the rider (Mr Ooi Kok Heong) said that he wanted to send the motorcycle to the workshop to check if there was any internal damage. We agreed for the motorcycle be sent to the workshop to assess the damage.

All parties agreed to go for a private settlement whereby the motorcycle and van drivers would go to their respective workshops and provide me with their claims.

On the same day around 2.35 pm, the van driver Whatsapped me the breakdown of his claim and put me in touch with his workshop. The next morning, 17 Jul 2021 the workshop Whatsapped me their Invoice for the repair cost. After a brief negotiation, the settlement amount was agreed and I settled the amount around noon time 17 Jul 2021 via OCBC Pay Now. I have also sent my car for repairs and paid the cost.

I sincerely hope that the damage to the motorcycle can be fairly verified, with the costs properly itemized. Where reasonable, I hope to come to a fair and amicable private settlement with the motorcycle driver soonest.
