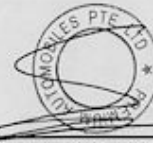

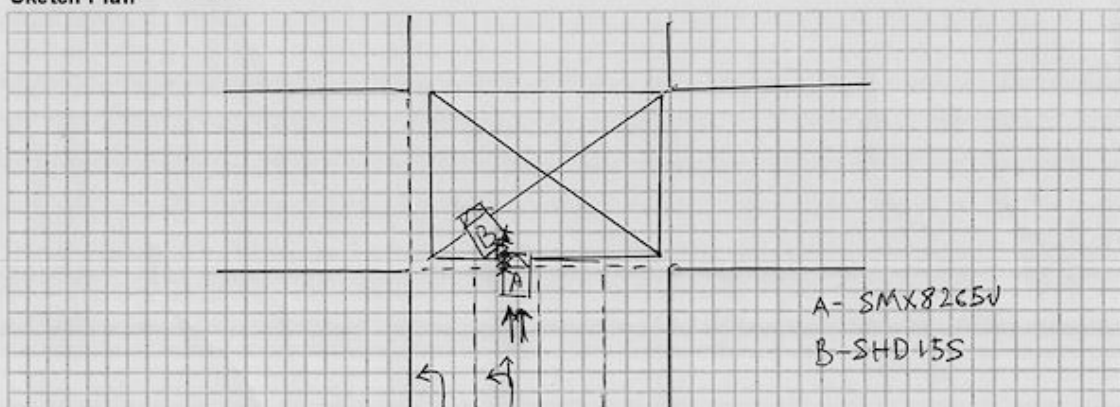

**Describe Circumstances of the Accident**


Was on the left most lane, where cars may either turn left or continue straight, on orchard road towards Handy road. Toward the junction, the road splits into two lanes, where the left side turns left and right side can either turn left or continue straight. As I was going to turn left after the junction, I stayed on the right (second lane from the left). In front of me there were two taxis, all of us stationary at the red light.


The light turned green and everyone started setting off. The cars in front turned left and continued straight. However, the cars turning left stopped, with the one most in front at the edge of the lane. By the time I saw them stop on the left side, it was too late to brake. The front left bumper of my car hit the back right corner of the taxi in front, as the taxi was mostly turned out of the lane but then stopped.

Traffic police quickly arrived and brought all cars to a safe location. No one was injured, no government property was damaged and the taxi hit was Singapore registered.
