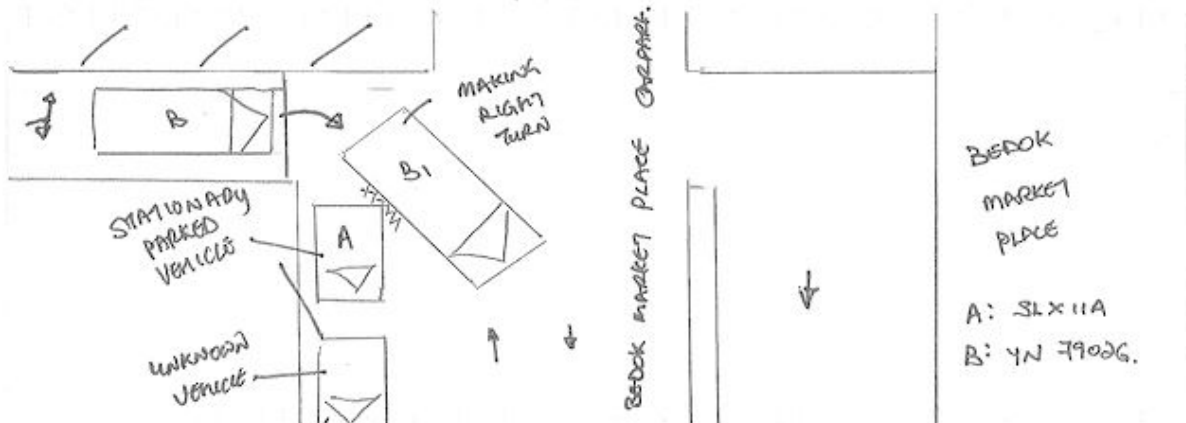

ON THE 17 JULY 2021 AT ABOUT 2PM, I HAD PARKED MY CAR SLX11A ALONG THE DRIVEWAY OF CARPARK OF BEDOK MARKET PLACE ALONG BEDOK ROAD, WHEN I WENT BACK TO MY VEHICLE AT ABOUT 10PM, I REALISED THAT THERE WAS SOME DAMAGE ON THE LEFT REAR PORTION OF MY VEHICLE. MY VEHICLE HAD BEEN HIT AND RUN WHEN MY VEHICLE WAS STATIONARY PRKED,. I THEN WHEN OVER TO TAMPINES NPC TO LODGE A REPORT T/20210717/2121. AFTER REPORTING, I WHEN BACK HOME AND CHECKED ON MY CAR CAMERA AND SAW FROM MY VIDEO THAT A LORRY FROM COLD STORAGE HAD COLLIDED ONTO THE REAR PORTION ON MY VEHICLE.
