due to minor road works ahead, I thus slowed down my vehicle to a halt at the 3rd lane. Sufficient checks were made prior to filtering out toward the second lane thereafter to overcome said traffic holdup. Concurrently, a second vehicle (in white) proceeded to filter from the first lane (far right) toward the second without a turn signal. Given my entry into the second lane, the driver of the white vehicle then decided to swerve back into the first lane, presumably given the speed at which he was travelling. This however resulted in a third vehicle (in black) executing a right swerve toward the construction barriers ahead. Both the white vehicle and mine thus came to a sudden halt without impact while the black vehicle collided mildly with the construction barriers ahead.

Under advisement from my car insurance agent, a police report was NOT made prior given its civil nature.
