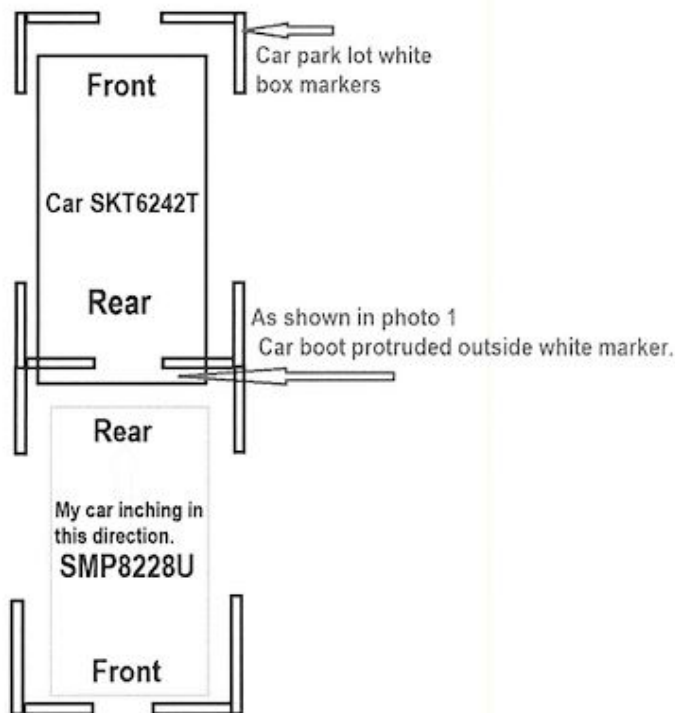

SKETCH PLAN**Describe Circumstances Of The Accident.**

Car park light was quite dim on that night (20/7/2021 time around 9pm) when I do my reverse parking. As usual, I do my reverse parking with taking reference of the established parking box white line marker as of the 4 point that can completely contained my vehicle to be parked inside the allowable space of the white box. However, I didn't noticed or anticipated there was a car "Parking/stopping beyond the boundaries of the parking lot thereby causing obstruction under parking Rule no. 13" having her rear car boot protruded outside the white box marker (refer to photo 1 and I am not sure whether this was done deliberately a not in the course of self interest), as I turned my head towards my rear car boot view to slowly inch my vehicle into the parking lot or box so as to park within the white box in an orderly manner and ensure not to obstruct others bypass vehicles.

After I brought my vehicle to a complete stop, engine off, my friend or rather/witness and me get out of the car, a woman approached me claiming that my rear bumper were parked possibly too near/coincide to her protruded rear car bumper. Intuitively and also on my friend side, there was no acknowledgement or registered a collision impact in our mind during the parking process or even the car was completely put to a complete parking status. To be a responsible driver, after the woman's stated her claims(refer above sentence), I therefore inspected her vehicle rear bumper (SKT6242T) (refer to photo 2) and can't determine any heavy damages. Hence, on the contrary, I also inspected my vehicle rear bumper (SMP8228U refer to photo 3) for signs of dented marks, cracks and paint being scratches or peeled off. But I found no sign of that also. So there won't be any claims on my car SMP8228U.

Reasons for delay in reporting the matter to authority AIG.

I had personally went down to Borneo Motor (Address : 17 Ubi Road 4 Singapore 408611) on 21/07/2021 at time around 4pm (as such the incident happened on 20/07/2021 9pm) but was unable to complete the reportings under the procedure due to queuing and department closing soon at 5pm. Was attended by Mr Sam San Joi.

However, I did tried my best and called up over the phone AIG **24-HOUR AIG AUTO HOTLINE: +65 6338 6200** for advise to further launching the report. I was attended by Miss Ada and was advised to launch the report via online portal on that day 21/07/2021 (refer to photo below). But the portal don't seems to actually work. So inconveniently, I have to do it again on 22/07/2021 in Borneo Motors.

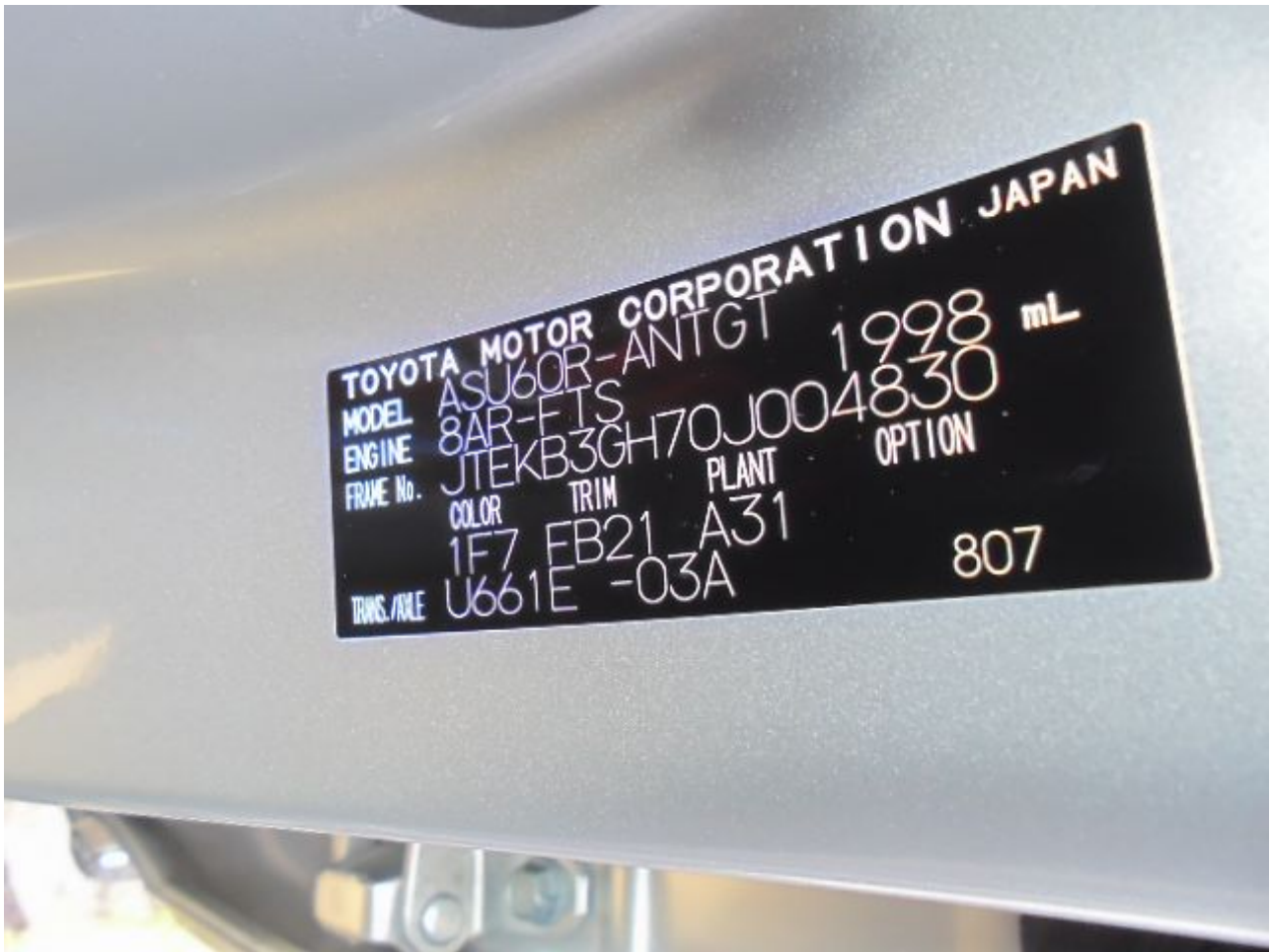
