Dear Sirs,

May I seek your assistance to perform a detailed mechanical inspection of the <u>22 vehicles</u> below. Those in <u>red</u> are deemed to be <u>urgent</u>:

- a. Case IAFP-IB-20210629 Mechanical Inspection of Motorcycle, JQR8144 (TP/IP/26771/2021)
- b. Case IAFP-IB-20210629 Mechanical Inspection of Van, GP6563K (TP/IP/26771/2021)

On 1 June 2021, at about 10.24 a.m., B1 (GP6563K) was travelling along Keppel Road towards MCE after AYE, on lane 3 of a 3 lane road. At the same time, A1 (JQR8144) was travelling slightly ahead of B1 on lane 2 of a 3 lane road, on B1's right. While B1 was negotiating a right bend, Suddenly B1 skidded to her right. Hence, collided onto A1 who was on her right. The impact pushes both vehicle to the right and landed on the right of the road on the drainage. Due to the accident, A1 was conveyed to SGH by the SCDF ambulance in an conscious state. However, B1 claimed that there were possible mechanical fault. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence raised by the defendant and to rule out foul play.

On 9 June 2021 sometime before 8.43 a.m., the Involved Party was driving her motorcar along PIE (Changi Airport) near to 19.9km mark when the Deceased who was riding his motorcycle, FBQ6529P on lane 2, in the process of overtaking the involved party motorcar from the left, side swiped onto the left front portion of the Involved party motorcar, lost control to the right and collided onto the guard railing and landed on the center divider. Deceased was pronounced dead on the spot at 9.25am by attending paramedics. Pillion rider of motorcycle was conveyed to TTSH where she succumbed to her injuries and passed away on the same day at 9.33am at TTSH. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence raised by the defendant and to rule out foul play.

On 7 June 2021 at about 0821 hrs, the rider of motorcycle, FU6482X was travelling along Woodlands Avenue 12 towards SLE on lane 1 of 3 lanes when the motorcycle collided onto rear of a van, GBG1047Z which was stationary due to red light ahead. On impact, the rider and his pillion fell into lane 2 where both rider and pillion were believed to be ran over by the rear right tyres of tipper, XE464JJ, that was travelling on lane 2 of 3-lane road. The pillion was pronounced dead at the scene while the rider was sent to KTPH for serious injuries. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence raised by the defendant and to rule out foul play.

A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence raised by the defendant and to rule out foul play.

On 19 May 2021 (Wednesday) at 9.33 a.m., the Deceased (who was riding motorcycle, FBA994C alone) was travelling along Woodlands Road slip road into KJE (PIE), which was left bend when he lost control of his motorcycle and self-skidded. As a result of the accident, the Deceased sustained chest injuries and was pronounced dead at the hospital. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence raised by the defendant and to rule out foul play.

The driver of Police truck, YQ2025E, claimed there was mechanical fault to the steering wheel which caused the vehicle to veer to the right. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence raised by the defendant and to rule out foul play.

A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence raised by the defendant and to rule out foul play.

Due to the accident, the Deceased who was reported to be unconscious and sustained head injury, was conveyed to Tan Tock Seng Hospital. On 17 June 2021 at 2.38 a.m., the Deceased succumbed to his injuries and was pronounced dead in Tan Tock Seng Hospital by Dr Oo Shuwen. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence raised by the defendant and to rule out foul play.
