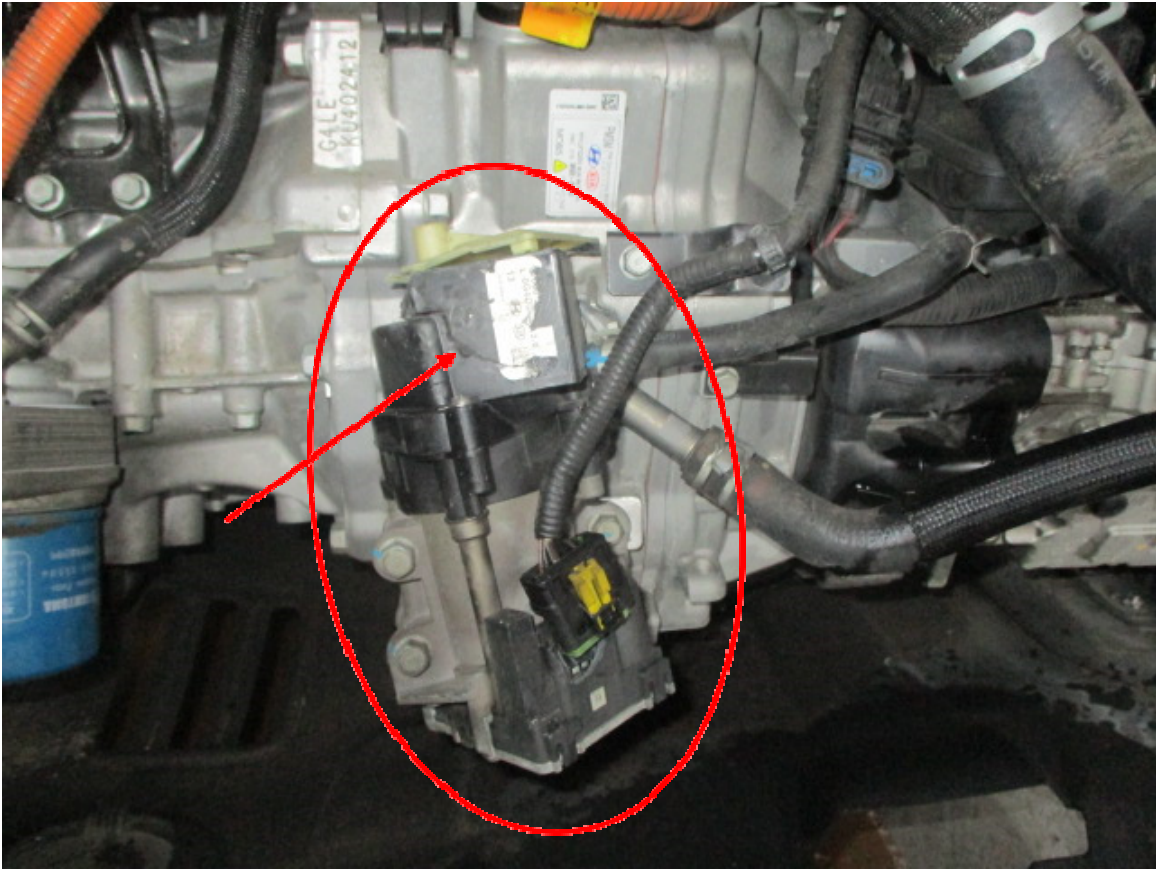

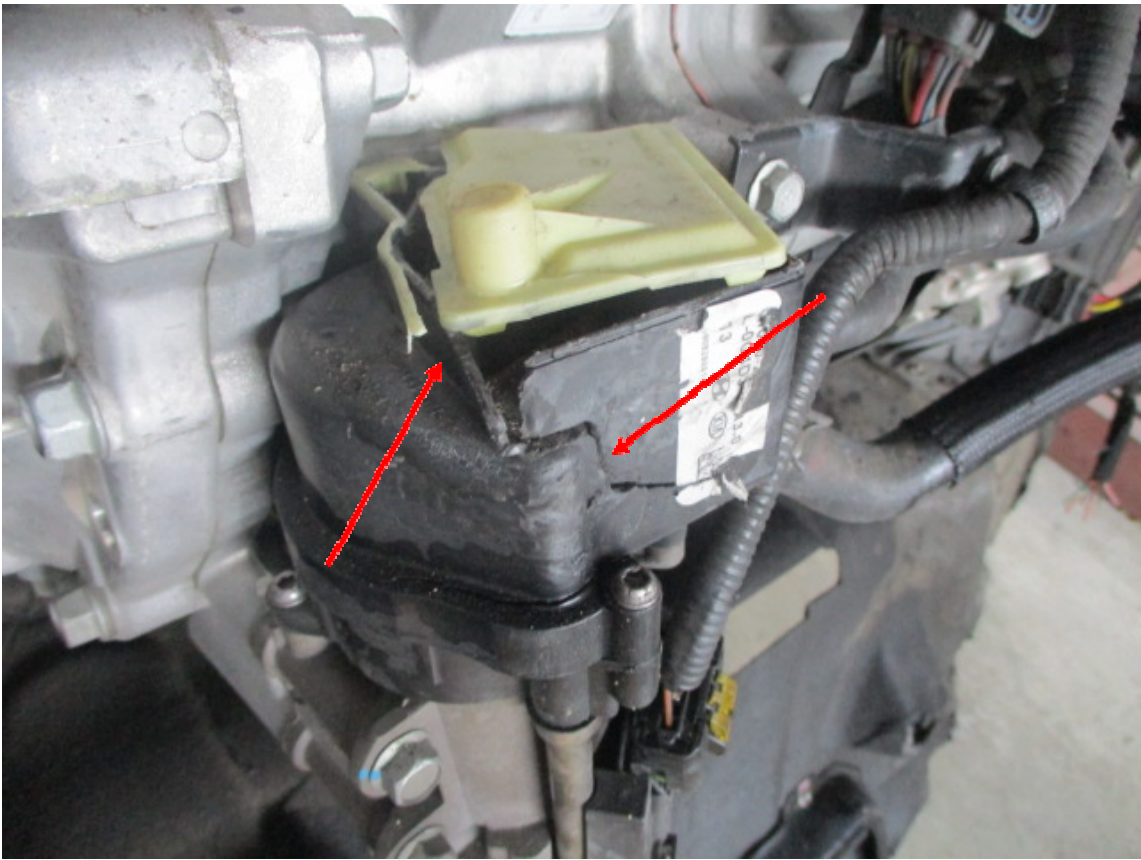


Photo 175 to 178 in Merimen are photos after the clutch pump was dismantled and show clear damages.
