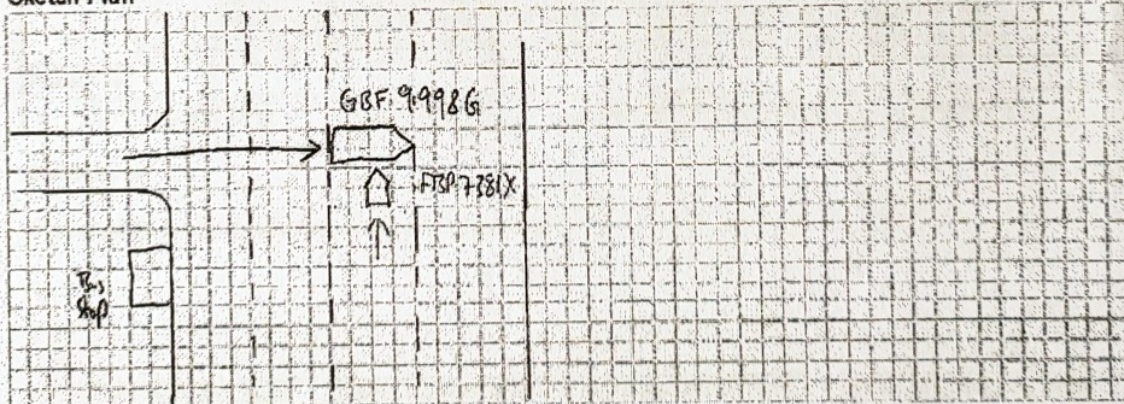

Brief Details.

I was travelling along Neil road on the third from left lane at approximately 50km/h. As I was riding, a blue van suddenly came out from the Everton Road side road and cut directly across 3 lanes into my lane and stopped. As this happened fast, I honked and applied my emergency brake. I noticed that when I honked the driver moved a bit more. The front of my bike hit the front right of the van and I was thrown forward headfirst. I landed heavily on the right side of my body. As I lay on the road, I saw the van driver inch away and then move off. I am unsure where he went. Some Passers by came to assist me. An eye doctor who happened to be there checked my pulse. A man then approached and mumbled sth to me which I could not make out. A Caucasian male passerby who was assisting me told me that was the van driver. I did not see the purported van driver after that. The paramedics then arrived and took me to SGH A&E.
