

## Describe Circumstances of the Accident

I was travelling along AYE (towards Jurong) on lane 1 to work, at approx 0810hrs, traffic was moderate and weather conditions was sunny.

~~Car A~~ (SLT6553J) in front of me slowed down and i followed to slow down to stop.

However, Car B (SMH704G) hit me from the rear, and causing my car to jerk and dent.


The accident happened on lane 1 of AYE (near lamppost 677F).


Damages to my car A (SLT6211H) are a) rear bumper dislodged and b) boot crushed in. Car able to move and had ~~neck~~ impact at the crash.
