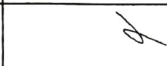

As I was travelling straight, I saw TP that was on my left was encroaching onto my lane. I proceed to horn TP to warn but to no avail, TP right rear vehicle collided onto my LHS mirror. There were no personnel injured due to this accident. I exchanged particulars with TP before continue my revenue service to Shenton Way and during my revenue service I called BOCC. BOCC requested me to report this incident to my supervisor at WITH. TP encroached onto my lane resulting in this accident. That is all.

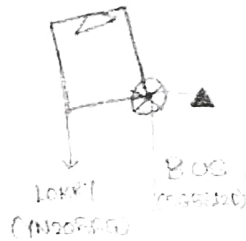
